

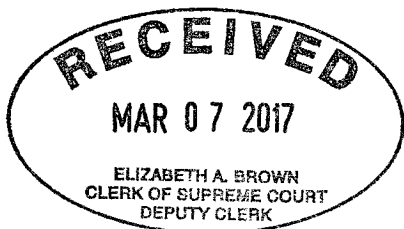
**Question 8** (Nature of the action): PERS stated that requested info "would be drawn from confidential files." Yet, NPRI requested an already-existing *actuary report* and, upon learning names in that annual report had been replaced with SSNs (which were, of course, redacted), requested compilation with another already-existing report, the *monthly payment register*. **Question 9** (Issues on appeal): PERS writes, "Whether a public agency has a duty to create a new document . . ." Rather, the issue is, "whether PERS has a duty to compile two already-existing public records?" **Question 12**: PERS checks "A substantial issue of first impression." Rather, *see PERS v. Reno Newspapers Inc.*, 129 Nev. Adv. Op. 88, 313 P.3d 221 (2013) and *LVMPD v. Blackjack Bonding*, 131 Nev. Adv. Op. 10, 343 P.3d 608 (2015).


