(emphasis added) in this proceeding, they shall notify this court within that same
time frame [30 days] that they do not intend to file an answer for that reason."

Ruby Hill does not desire to file any additional papers with the Supreme Court in this matter or to directly participate in this matter before the Court, but not specifically for the two reasons listed by the Court in the Order.

Ruby Hill finds itself in the position of having an *interest* in the outcome,
for sure, but Ruby Hill does not desire to file an answer *against the issuance of the requested writ*, primarily because Ruby Hill supported the position espoused
by the Petitioners here at the District Court level. Ruby Hill has confidence the
Petitioners will fully brief and present the matter to this Court without the need
for additional filings and presentation of papers by Ruby Hill, and therefore Ruby
Hill will not be filing papers for consideration by the Supreme Court.

Nevertheless, Ruby Hill would not necessarily characterize itself as one
that does not believe it is an "interested party" in this proceeding. Rather, while
Ruby Hill will quite clearly be affected by the outcome of this proceeding and is
very interested in the result, Ruby Hill simply desires to await the briefing and
argument of others who will capably present this matter to the Court for its
consideration.
