## ORDER

On March 16, 2017, this court entered an order directing real parties in interest, on behalf of respondents, to file and serve answers against issuance of the writ requested in this matter. Our order additionally directed that if "any of the named real parties in interest do not believe they are interested parties in this proceeding," they were to notify this court. Real parties in interest Sadler Ranch, LLC, Roger B. Allen, and Judith B. Allen have filed answers to the petition. The other real parties in interest did not file answers to the petition, but have filed responses to our order.

First, numerous parties<sup>1</sup> filed a single response noting that their interests "are aligned with those of Petitioners" and they "therefore support the granting of the writ." We elect to treat this document as a joinder in the petition and conclude that these parties should be designated as petitioners, rather than real parties in interest, in the caption of this matter. The clerk shall conform the caption on this court's docket to the caption on this order.<sup>2</sup>

Additionally, real party in interest Ruby Hill Mining Company, LLC, filed a response indicating that it has an interest in the outcome of this matter, but "does not desire to file any additional papers with the Supreme Court in this matter or to directly participate in this matter before the Court." Ruby Hill shall have five days from the date of this order to file and serve a notice specifically informing this court that (1) it joins in the

petition; (2) it opposes the petition; or (3) as it neither joins nor opposes the petition, it should be removed from the caption in this matter.
