Nevada Rule of Appellate Procedure 41(b)(2) provides in pertinent part:

Petition for Rehearing or En Banc Reconsideration: "....If the petition is denied, the remittitur shall issue 25 days after entry of the order denying the petition, unless the time is shortened or enlarged by order."

Nevada Rule of Appellate Procedure 41(b)(3) provides in pertinent part:

Application for Certiorari to the United States Supreme Court: A) A party may file a motion to stay the remittitur pending application to the Supreme Court of the United States for a writ of certiorari. The motion must be served on all parties. B) The stay shall not exceed 120 days, unless the period is extended for good cause..."

This Court denied Mr. Belcher's Petition for Rehearing on October 23, 2020. This is a capital case. As such, Mr. Belcher respectfully requests this Court stay the issuance of Remititur for 90 days so that he may proceed with a Writ of Certiorari to the United States Supreme Court.
