**STIPULATION TO EXTEND TIME
TO FILE OPENING BRIEF
(FIRST REQUEST)**

Pursuant to NRAP 26(b)(2) and 31(b)(2), Appellant Pardee Homes of Nevada (“Pardee”) and Respondents James Wolfram, Angela L. Limbocker-Wilkes, as trustee of the Walter D. Wilkes and Angela L. Limbocker-Wilkes Living Trust, and Walter D. Wilkes and Angela L. Limbocker-Wilkes Living Trust (collectively “Respondents”) stipulate to extend the deadline for the opening brief for 30 days.
