This appeal involves certain written contracts between appellant Pardee Homes of Nevada, Inc. ("Pardee") and non-party Coyote Springs Investment, LLC ("CSI"). Each of these contracts (the "Confidential Agreements") includes a confidentiality and non-disclosure provision prohibiting Pardee or CSI from publicly disclosing their terms and provisions.

During the trial below, the district court entered a protective order permitting Pardee and respondents James Wolfram and Walt Wilkes to file these documents under seal. The protective order also allowed the parties to redact any filing that contained the Confidential Agreements' specific language. Finally, portions of the trial transcripts were designated as confidential if the testimony included the Confidential Agreements' terms and provisions, and the Confidential Agreements themselves were trial exhibits.
