**MOTION FOR EXTENSION TO FILE REPLY BRIEF**

Additional time is even more necessary here, however, to ensure the Court is thoroughly apprised of all relevant authorities, arguments and counterarguments, to facilitate its adjudication of this question of statewide, public importance—the resolution of which will impact the amount of damages awardable in every lawsuit against a physician assistant that was filed prior to June 9, 2015. Therefore, petitioner respectfully requests an additional 30 days to file its reply brief.
