DECLARATION OF SHARON G. DICKINSON

- 1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.
- 2. Our office filed the Notice of Appeal in this matter on April 17, 2017. The Opening Brief was due on October 16, 2017. However, we obtained a continuance by way of stipulation making the brief due today, November 15, 2017. I am seeking a continuance today based on the following facts.
- 3. Within the last few hours I received notice from this Court regarding Mr. Harvey request to change counsel. The notice was prepared by Attorney Timothy Treffinger, Esq., Bar #12877, and signed by Mr. Harvey. Prior to receiving the filed notice from this Court, I had no indication from Mr. Harvey that he wanted to hire another attorney. The signature on this notice that purports to be mine is not. Apparently, a clerk in our main office signed off on the document today with a stamped signature and never notified me.
- 4. Attorney Treffinger's Motion to substitute in as an attorney uses NRAP 46(a)(2) as the basis for his substitution. However, NRAP

46(d)(2) is the rule for substituting new counsel in a criminal case from a different firm. NRAP 46 (d)(2) states:

(2) **Substitution.** A substitution or change of counsel may be effected by serving and filing a substitution in the Supreme Court or Court of Appeals, signed by the affected attorneys and the client or, in lieu of the client's signature, an affidavit of counsel stating that the client has been informed of and consents to the substitution. The Supreme Court or Court of Appeals may disapprove a substitution that does not have the necessary signatures or affidavit.

Because Attorney Treffinger's notice does not contain a signature from the District Attorney's Office, I am unsure if this Court will require him to obtain that signature before granting substitution. Accordingly, I am filing this request for an extension because under NRAP 46 (d)(2), it appears that I remain as attorney of record until this Court issues an order.

5. Although I am almost finished completing the Opening Brief, I was in the middle of conducting an investigation regarding an exhibit I found in the court documents when I received the notice. In view of Mr. Harvey's apparent desire to be represented by someone else, I have stopped working on his case and stopped further investigation until I receive direction from this Court.
