MOTION TO SEAL SELECTED PORTIONS OF APPENDIX

Appellant, Kirk Ross Harrison, hereby moves for an order to file selected portions of the appendix to his child custody fast track statement under seal, pursuant to the Nevada Rules for Sealing and Redacting Court Records (SRCR). More specifically, Appellant requests that the documents identified as 3316-3375 (Exhibit 1) and 3385-3387 (Exhibit 5) in the appendix be filed under seal.


SRCR 3(1) provides that any person may request that the court seal or redact court records for a case that is subject to these rules by filing a written motion. SRCR 4 (f) and (h) respectively further outline that the court may order court files and records to be sealed or redacted if (1) the sealing or redaction includes medical, mental health or tax records or (2) the sealing or redaction is justified or required by another compelling circumstance. Further, SRCR 7 provides for the use of sealed records on appeal. More specifically, SRCR 7 provides that “A civil court record or

any portion of it that was sealed in the trial court shall be made available to the Nevada Supreme Court in the event of an appeal. Court records sealed in the trial court shall be sealed from public access in the Nevada Supreme Court subject to further order of that court.”

Here, the selected portions of the appendix that Appellant requests to seal were marked as confidential exhibits at an evidentiary hearing conducted by the district court on January 18, 2017. Further, the document identified as 3316-3375 (Exh. 1) in the appendix is a report authored by John Paglini, Psy.D. pertaining to minor Brooke Harrison. Similarly, the document identified as 3385-3387 (Exh. 5) in the appendix is a letter from Jamil Ali, Psy.D. pertaining to minor Brooke Harrison.

Because the selected portions of the appendix identified herein were marked as confidential by the district court and contain confidential information pertaining to a minor, Appellant requests that these documents be filed under seal. The documents are being mailed to the Nevada Supreme Court, marked “Confidential.”
