Somehow, my appeal of Marquie Arubach Coffing's Legal fees NSC number was changed to the same NSC number as my appeal of Brownstein's legal fees from 72766 to 72897 in error.

The fact is both of these attorney's fees were both created by the demands of Temporary Trustee Fred Waid for the W N. Connell and Marjorie T. Connell Living trust 5 18, 1979.

I received no benefit for the money they are both charging.

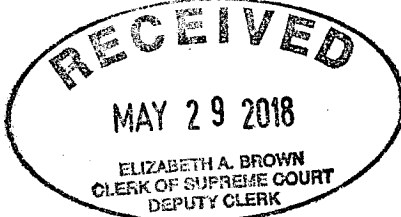
I did not know Fred Waid, Temporary Trustee, was demanding legal documents trying to prove I did something wrong. He could not document anything I did wrong except borrow \$500,000 from the 65% fund Judge Sturman ordered. set aside. I used all the money to pay legal bills. There was plenty of money to pay this back from my then 35%. Tammy Peterson my lawyer with the Brownstein Law Firm, sent a letter to Fred Waid, TT, requesting \$400,000 be Tendered in 2015 to start the payback then to Tender \$100,000 to complete the payback. There was no response from Fred Waid. No payback was ever initiated. Today my father's trust is earning \$100,000,000 as month. I was told by the Illegal guardian ad litem I was out of debt. No one has communicated that to me by official letter. Nor have I received any substantial money from my trust.

I analyzed Brownstein's bill and learned more than 75% of the legal fees were created by Fred Waid's demands. I paid MAC in full just before Fred Waid was appointed as Temporary Trustee April 1, 2015. Mac's legal fees were 100% generated by Fred Waid, TT

To this date, I have NOT received any Certified accounting of what has happened to my father's land, Oil Wells and money that he gave to me in the 1972 W. N. Connell and Marjorie T. Connell Trust and confirmed by the 2009 Reconstruction of the 1972 Trust., Order signed by Judge Ritchie. Both documents state I have a life estate interest and the Girls must wait till I die to receive any money from the oil and gas royalty. How could the NSC have missed this wording in both of these two documents. Is it possible Kirk Lenhard, my lawyer, did not present this argument? The one and only accounting to the District Court 26, was completely bogus without documentation or certification by an honorable CPA, like Gammet and King CPAs. Shawn King is my Trust's CPA.
