

- On June 26, 2014, the Honorable Nancy A. Becker, Senior District Judge, heard argument on several motions in this case. The Court ruled on some of the motions and the remaining motions were taken under advisement after oral argument. Upon review of the minutes of June 26, 2014, the Court notes an error in the minutes with regard to one of the motions - specifically Defendants Dale, Mayer and Rick's Restoration Motion to Strike Punitive Damages. The minutes reflect the motion was denied in its entirety. This is inaccurate. The Court denied the motion in part and granted it in part. The Court noted punitive damages were not available as a matter of law in Plaintiff's contract and quasicontractual claim and any punitive damages claims were linked to any tort claims. With respect to the motions that were taken under advisement, the Court sets forth its decisions below.

Defendants' Dale, Mayer and Rick's Restoration Motion to Dismiss the First, Fifth, Sixth, Seventh and Eighth Causes of Action in the First Amended Complaint. The motion is DENIED IN PART and GRANTED IN PART. Many of the factual allegations and actions are an attempt to revive claims that were dismissed by summary judgment on August 29, 2013. Any amended complaint should have been limited to the claims that were remaining after the granting of summary judgment, not a restatement of the dismissed claims with additional facts. The remaining claims are not cognizable at

law. Specifically:

- 1. Any claim beyond that is STRICKEN and the motion is GRANTED WITH PREJUDICE as to allegations that final agency agreement was created on August 26, 2011. Should Plaintiff prevail on the temporary agency contract theory, then any damages are those which Plaintiff can prove pursuant to contract law relating to the breach of that agreement.
- 2. The Fifth claim Unjust Enrichment this is a quasi-contractual claim plead in the alternative in the event Plaintiff cannot prove the Breach of Contract claim. To the extent that the allegations go beyond this time period, they are STRICKEN and the motion is GRANTED WITH PREJUDICE as to those allegations.
- 3. The Sixth claim Detrimental Reliance this is a theory of liability, not a cause of action and it is DISMISSED WITH PREJUDICE.
- 4. The Seventh claim Quantum Merit this is a quasi-contractual claim plead in the alternative in the event Plaintiff cannot prove the Breach of Contract claim. As with the Breach of Contract claim, it is limited to the time period August 26, 2011 to October 31, 2011. To the extent that the allegations go beyond this time period, they are STRICKEN and the motion is GRANTED WITH PREJUDICE as to those allegations.
- 5. The Eighth claim Vicarious Liability this is a theory of liability and not a cause of action. It is DISMISSED WITH PREJUDICE. However, Plaintiff may amend the First Amended Complaint to add this theory of liability against Rick's Restoration in the factual assertion at the beginning of the Complaint.

Counsel for Defendants Dale, etc. shall prepare the order on this motion and submit it to opposing counsel for review pursuant to the applicable court rules.

Defendants Gold & Silver Pawn Shop, Richard and Corey Harrison Motion to Dismiss Plaintiff's Defamation claim is GRANTED WITH PREJUDICE. The statements listed in the complaint are pure opinion and there is nothing about the place or manner in which they were stated that suggests a mixed question of opinion and factual assertion. Even assuming the Harrisons' made the statements attributed to them, they are not factual assertions or a statement of opinion that suggests a factual basis unfavorable to Plaintiff exists for their refusal to work with him. Thus the statements are not defamatory as a matter of law and the claim fails to state a cause of action. As this resolves all claims against these defendants and the claims are separate and distinct from the remaining claims and parties in the case, the request for NRCP 54(b) certification is GRANTED. The Defts' agree Pltf. is owed some money for commission on sales that occurred during the three month period which is about \$5,000.00 and not an amount that would warrant jurisdiction by the Court. As to the third and fourth causes of action, Ms. Hanlon argued there is no issue that there is quasi contractual issues here because that would be premised on there being a contract which there is not. Further, punitive damages were previously stricken as to the contractual and now striking them as to the tortious. Ms. Hanlon believes the parties need to go to a settlement conference with these rulings firmly in place so it can be determined as to what Pltf. is owed for the three month period of time. Additional argument by Mr. Alexander. Court stated there are two separate issues that need to be bifurcated. If counsel can satisfy his burden and the jury agrees with counsel with respect as to whether or not there was a contract agreement for Pltf. and only if at that point, the Court will give counsel opportunity to present additional evidence with an expert to support Pltf would be entitled to future commissions.
