DECLARATION OF HOWARD S. BROOKS

- 1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.
- 2. A jury convicted Javier Righetti of Attempt Robbery, Battery With Intent to Commit Sexual Assault, First Degree Kidnapping, Attempt Sexual Assault With a Child Under 16 Years of Age; Sexual Assault With a Child Under 16 Years of Age; Robbery With Use of a Deadly Weapon; First Degree Kidnapping With Use of a Deadly Weapon; Sexual Assault With a Child Under 16 Years of With Use of a Deadly Weapon; Sexual Assault with a Child Under 16 Years of Age With Use of a Deadly Weapon; and First Degree Murder With Use of a Deadly Weapon.
- 3. The jury sentenced Righetti to death for the crime of First Degree Murder With Use of a Deadly Weapon.
- 4. The Judgment of Conviction was filed May 8, 2017. The Clark County Clerk's Office filed the Notice of Appeal the same day.
 - 5. The Opening Brief is currently due to be filed October 5, 2017.
- 6. The Record on Appeal consists of 51 volumes containing more than 11,000 pages.
 - 7. To date, I have reviewed 2,200 pages of the 11,000 page record.
- 8. My progress on this matter has been delayed, in part, by the fact that I am also working to complete an appeal of the Michael Johnson v. State matter, Case No. 72401, where the record is also voluminous. I have just sought and received a

continuance for the filing of the Opening Brief in that matter, which is now due in November.

- 9. The Righetti matter is a complicated case involving ten criminal convictions. I am hoping I can complete the review of the complicated and voluminous record and prepare the Opening Brief within ninety-nine (99) days. Therefore, I am requesting a continuance to January 12, 2018.
- 10. This Motion for Extension is made in good faith and not for the purpose of delay.
