### JUDGMENT

The Defendant, having entered a plea of Guilty, and no sufficient cause being shown by Defendant as to why judgment should not be pronounced against him, the Court renders judgment as follows:

That Tomisha Tyronda Montgomery is guilty of the crime of Battery Resulting In Substantial Bodily Harm Committed Against An Older Person, a violation of NRS 200.481(2)(b) and NRS 193.167, a category C felony, as charged in the Information, and that he be punished by imprisonment in the Nevada Department of Corrections for the maximum term of sixty (60) months with the minimum parole eligibility of eighteen (18) months, with credit for one hundred fifty (150) days time served, with a consecutive term of imprisonment in the Nevada Department of Corrections for the maximum term of one hundred twenty (120) months with the minimum parole eligibility of forty-eight (48) for committing the crime against an Older Person. The aggregated sentence imposed is a maximum of one hundred eighty (180) months with the minimum parole eligibility of sixty-

six (66) months. Further, the Defendant must submit to a DNA Analysis Test for the purpose of determining genetic markers and pay a One Hundred Fifty Dollar (\$150.00) DNA analysis fee; and pay restitution in the amount of Three Hundred Fifty Two Dollars and Seven Cents (\$352.07). Defendant is further ordered to pay a Three Dollar (\$3.00) administrative assessment for obtaining a biological specimen and conducting a genetic marker analysis and a Twenty-Five Dollar (\$25.00) administrative assessment fee to the Clerk of the Second Judicial District Court.

The fees and restitution are subject to removal from the Defendant's books at the Washoe County Jail and/or Nevada Department of Corrections.
