16 **CORRECTED JUDGMENT**

17 *(This Corrected Order is being entered to correct the Defendant's name on page one, line*
18 *20 ½)*

19 The Defendant, having entered a plea of Guilty, and no sufficient cause
20 being shown by Defendant as to why judgment should not be pronounced against him, the
21 Court renders judgment as follows:

22 That Juan Jose Rodriguez is guilty of the crime of Battery Resulting In
23 Substantial Bodily Harm Committed Against An Older Person, a violation of NRS
24 200.481(2)(b) and NRS 193.167, a category C felony, as charged in the Information, and
25 that he be punished by imprisonment in the Nevada Department of Corrections for the
26 maximum term of sixty (60) months with the minimum parole eligibility of eighteen (18)
27 months, with credit for one hundred fifty (150) days time served, with a consecutive term of
28 imprisonment in the Nevada Department of Corrections for the maximum term of one
hundred twenty (120) months with the minimum parole eligibility of forty-eight (48) for
committing the crime against an Older Person. The aggregated sentence imposed is a

1 maximum of one hundred eighty (180) months with the minimum parole eligibility of sixty-
2 six (66) months. Further, the Defendant must submit to a DNA Analysis Test for the
3 purpose of determining genetic markers and pay a One Hundred Fifty Dollar (\$150.00)
4 DNA analysis fee; and pay restitution in the amount of Three Hundred Fifty Two Dollars
5 and Seven Cents (\$352.07). Defendant is further ordered to pay a Three Dollar (\$3.00)
6 administrative assessment for obtaining a biological specimen and conducting a genetic
7 marker analysis and a Twenty-Five Dollar (\$25.00) administrative assessment fee to the
8 Clerk of the Second Judicial District Court.

9 The fees and restitution are subject to removal from the Defendant's books at
10 the Washoe County Jail and/or Nevada Department of Corrections.
