### **RESPONSE TO ORDER TO SHOW CAUSE**

Appellants, by and through their undersigned counsel, Tory M. Pankopf respond to the court's order to show cause, filed November 22, 2017, why the appeal should not be dismissed as follows:

The order granting the motions to dismiss was a final order mooting the two petitions<sup>1</sup> to set aside the estate of the decedents and therefore left nothing for the future consideration of the district court. <u>Lee v. GNLV Corp.</u>, 116 Nev. 424, 426,

996 P.2d 416, 417 (2000). The order validated the foreclosure sale of the real property that was the only property in the two petitions to be set aside to the decedents heirs.<sup>2</sup> Prior to the foreclosure sale the purported owner of the note and beneficiary of the deed of trust were considering the estates for a foreclosure prevention alternative. NRS 107.530 et. seq., i.e., Nevada Home Owners' Bill of Rights. It was necessary for title to the subject property to pass to the heirs so they could execute a grant deed and sales documents. The district court also entered an order canceling the notices of pendency of action pertaining to the petitions and the complaint itself.<sup>3</sup>

Consequently, it would be a waste of judicial resources to proceed to a hearing on the petitions where the subject property has been judicially determined by the order dismissing the complaint to no longer be an asset of each estate which, thereafter, rendered the petitions moot.

The order resolved all the claims/issues in the consolidated cases and left nothing for the future consideration of the district court. <u>Lee</u>. Based thereon, the challenged order is appealable as a final judgment and the appeal should not be
