ORDER MODIFYING RULE AMENDMENT

On March 9, 2018, this court entered an order amending the Nevada Rules of Professional Conduct (RPC) 7.1 and 7.2. We have determined that, due to a typographical error, the amendment to RPC 7.2 in Exhibit A in our March 9, 2018, order requires modification. Specifically, the petitioners intended to reference RPC 1.5(e), not RPC 7.1(e), in subsection (a) of RPC 7.2. Accordingly, we direct the clerk of this court to modify Exhibit A to the order filed on March 9, 2018, by deleting “7.1(e)” in subsection (a) of RPC 7.2 and adding “1.5(e).” The amended subsection (a) of RPC 7.2 will now read: “Except as allowed under Rule 1.5(e), a lawyer shall not give anything of value to a person for recommending the lawyer’s services, except that a lawyer may pay the reasonable cost of advertising or written or recorded communication permitted by these Rules and may pay

the usual charges of a lawyer referral service or other legal service organization.”

It is so ORDERED.

EXHIBIT A
AMENDMENT TO RULES 7.1, 7.2, 7.2A, AND 7.2B OF THE NEVADA
RULES OF PROFESSIONAL CONDUCT

* * *

Rule 7.2. Advertising.

Subject to the requirements of Rules 7.1 and 7.3, a lawyer may advertise services through written, recorded, or electronic communication, including public media.

(a) Except as allowed under Rule ~~[7.1(e),]~~ 1.5(e), a lawyer shall not give anything of value to a person for recommending the lawyer's services, except that a lawyer may pay the reasonable cost of advertising or written or recorded communication permitted by these Rules and may pay the usual charges of a lawyer referral service or other legal service organization.
