POINTS AND AUTHORITIES

NRAP 41 (b)(3)(A) provides for a stay of the issuance of this Court's remittitur pending filing of a petition for certiorari in the United States Supreme Court. "A party may file a motion to stay the remittitur pending application to the Supreme Court of the United States for a writ of certiorari." Once the petition is filed, "the stay shall continue until final disposition by the Supreme Court of the United States." NRAP 41(b)(3)(B).

In this case, Mr. Castillo filed a Renewed Motion to Stay
Remittitur on January 29, 2020. Mr. Castillo requested the stay in
order to file a petition for certiorari in the United States Supreme Court
on February 3, 2020. In response, on February 12, 2020, this Court
ordered the remittitur stayed until February 18, 2020 if the clerk of this
Court received written notice by the clerk of the United States Supreme
Court that Mr. Castillo had filed a petition for writ of certiorari.

According to this Court's docket, on February 19, 2020, this Court issued the remittitur in Mr. Castillo's case **and** received written notice that Mr. Castillo filed a petition for certiorari in the United States

Supreme Court on February 12, 2020 in case number 19-7647.

Based upon the fact Mr. Castillo's petition for writ of certiorari was filed on February 12th, Mr. Castillo requests the Court recall the remittitur as it appears its issuance was inadvertent. *See Wood v. State*, 60 Nev. 139, 141, 104 P.2d 187, 188 (1940) (holding that remittitur can be recalled when inadvertence, mistake of fact, or an incomplete knowledge of the circumstances of the case on the part of the court exists).
