**RESPONDENTS' MOTION FOR EXTENSION OF TIME
TO FILE RESPONDENTS' ANSWERING BRIEFS**

Pursuant to Nevada Rule of Appellate Procedure 26(b)(1), respondents California Reconveyance Company, Quality Loan Service Corporation, National Default Servicing Corporation, and MTC Financial, Inc. move the Court to extend the deadline by thirty (30) days to May 9, 2018 for respondents to file their answering briefs, which are currently due on April 9, 2018.

After respondents stipulated to appellants' request for an additional thirty days to file their opening brief, appellants filed their opening brief on March 8, 2018. The opening brief concerns the activities of respondents, who are five non-judicial foreclosure trustees separately represented in this litigation. Due to the number of respondents and counsel involved, respondents request an additional thirty days, including through May 9, 2018, to prepare and file their answering briefs. Respondents have not previously sought any extension of time with the Court to file their answering briefs. Good cause exists for the extension.¹

Based on the foregoing, respondents respectfully request the Court grant a thirty day extension of time, including through May 9, 2018, for respondents to file their answering briefs.

¹ On March 21, 2018, appellants agreed in writing to respondents' request for an additional thirty days of time, but appellants would not agree to the stipulation for extension of time that respondents drafted. Accordingly, respondents filed this motion for an extension of time.
