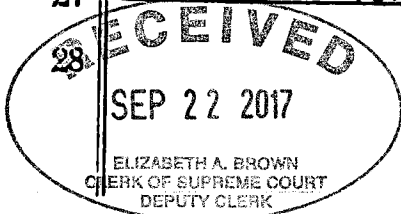

18 This Court DENIED petitioner's WRIT OF
19 MANDAMUS because petitioner did not include
20 an appendix of exhibits with his petition.
21 However, petitioner did not have any supporting
22 documents in his possession. Petitioner requested
23 orally at the Hearing on the day of July 5,
24 2017 the transcripts for the motion to dismiss
25 Attorney of record, his Deputy(ies) and the
26 Substitute of Counsel and dismissal of Criminal
27 Information for speedy Trial violations.



1 And upon the oral request the district court
2 Judge Elissa F. Cadish said "NO" to petitioner.
3 Petitioner filed a motion for transcripts with
4 the District Court requesting transcripts so that
5 petitioner could attach said documents with
6 his mandamus. However, the court never
7 provide said documents. Therefore petitioner
8 respectfully request that this Honorable Court
9 either mandates the District Court to provide
10 supporting documents, so that petitioner can
11 attach said documents OR that this court
12 vacate and stay its decision so that
13 petitioner can try again to obtain said
14 documents from the District Court. In addition
15 petitioner needs 30 day to obtain said
16 documents from the District Court, to send
17 to the Supreme Court of NEVADA.
