8 District Court Clerk the original rough draft transcript(s)  
9 requested herein.

11 Further, pursuant to NRAP 3C(d)(3)(iii), the court  
12 reporter shall also deliver copies of the rough draft transcript  
13 to appellant's counsel and respondent counsel no more than twenty  
14 (20) days after the date of the appellant's request.
