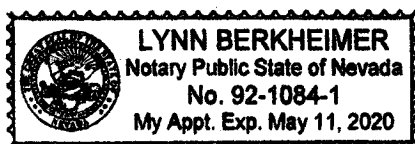
10 2. That this request has been sent out to an outside transcriber and at the request


