**RESPONDENTS' MOTION TO ENLARGE TIME TO FILE ANSWERING
BRIEF**

Respondents DANA ANDREW, AS LEGAL GUARDIAN ON BEHALF OF RYAN T. PRETNER, and RYAN T. PRETNER hereby move to enlarge the time for Respondents to file their Answering Brief in the above-entitled matter. On October 18, 2017, The Federation of Defense and Corporate Counsel filed its Motion for Leave to File *Amicus Curiae* Brief. Two days later, The Complex Insurance Claims Litigation Association and the Property Casualty Insurers Association of America filed their Motion for Leave to File *Amicus Curiae* Brief.

Respondents anticipate that this Court will grant the *Amici Curiae's* Motions because this Court previously allowed The Complex Insurance Claims Litigation Association and Property Casualty Insurers Association of America to file their

Amicus Brief in *Nalder v. United Automobile Insurance Company*, Case No. 70504, which concerns the exact same certified question of law at issue in this matter.
