**STIPULATION FOR EXTENSION OF TIME FOR RESPONDENTS TO FILE
THEIR ANSWERING BRIEF**

Appellant CENTURY SURETY COMPANY and Respondents DANA ANDREW, AS LEGAL GUARDIAN ON BEHALF OF RYAN T. PRETNER, and RYAN T. PRETNER hereby stipulate to extend the time for Respondents to file their Answering Brief regarding the certified question of law by fifty-six (56) days up to and including January 5, 2018.

On October 25, 2017, Respondents filed a Motion to Enlarge Time to File Answering Brief. On November 7, 2017, the Court ordered Respondents to pay their half of the \$250.00 filing fee, and indicated that it would not rule on Respondents' Motion until the fee was paid. On November 9, 2017, Respondents paid the filing fee. The Court has not yet ruled on Respondents' pending Motion.

As expected, this Court recently allowed *Amici Curiae* to file their respective amicus briefs in this matter. Additionally, Respondents' undersigned counsel of record, Dennis M. Prince, Esq., begins trial on November 27, 2017 in the case of *Yannatone v. Drake*, Eighth Judicial District Court Case No. A-15-713605-C. Mr. Prince is lead trial counsel in *Yannatone* and the trial is expected to last approximately two to three weeks. During this trial, the undersigned counsel will be unable to devote the significant time necessary to address the important legal issue in a thorough manner for this Court's consideration. Furthermore, Mr. Prince has a reply brief to an answering brief on cross-appeal due in the matter of *Capanna v. Orth*, Case No. 69935 due to this Court on December 7, 2017. This extension of time will ensure that Respondents have the requisite time to comprehensively address all of the arguments contained in Appellant's Brief and the *Amici Curiae's* Briefs regarding the significant question of law before this Court.

Further, this request is not meant to prejudice Appellant or cause undue delay.
