## MEMORANDUM OF POINTS AND AUTHORITIES

The appeal of an order granting or refusing to grant an injunction or dissolving or refusing to dissolve an injunction is an appealable determination under Nev. R. App. Pro. 3(b)(3). The Order in question was issued on August 7, 2017. Notice of entry was given on August 8, 2017.

On August 16, 2017 the Anthonys met with and retained undersigned counsel. On August 21, 2017 counsel prepared and filed in the district court an answer and counterclaim and a motion to alter or amend the August 7, 2017 Order.

The counterclaim and motion are based upon perceived Article Nine violations which are set forth in detail in the counterclaim and motion. A motion to alter or amend under Nev. R. Civ. Pro. 59 tolls the time to file a notice of appeal. See Nev. R. App. Pro. 4(a)(4)(C).

The filing of an appeal divests the district court of jurisdiction. For that reason, the Anthonys are filing a withdrawal of the notice of appeal so they can have the district court rule on their motion to alter or amend the August 7, 2017 order.
