THE DEFENDANT: I need headphones, Judge.

THE COURT: -- find that the Defendant meets the criteria to be considered competent to proceed with adjudication. Counsel will you state your appearance please.

MR. PATRICK: Clark Patrick and Michael Hyte for Mr. Randolph.

THE DEFENDANT: Clark, I need headphones.

THE COURT: Okay. What's your position?

MR. PATRICK: I'm sorry, Judge. Do we have the headphones? Mr. Randolph is very hard of hearing.

THE COURT: Drs. Slagle and Glovinsky find the Defendant meets the criteria to be considered competent to proceed. What's your position?

MR. PATRICK: Your Honor, we have no challenge; however, I'm concerned that we will probably be back here before too long.

Mr. Randolph was doing fine and was competent until in February, three months before trial, CCDC through Naphcare unilaterally decided that the medication that has been working for Mr. Randolph for 22 years was no longer to their liking. They changed his medication, rendering him incompetent due to the withdrawal from the opioids.

Even Dr. Slagle, when finding him competent, mentioned in his report that Mr. Randolph needs to be on pain management that works, and what – where we're at now is –

THE COURT: I didn't hear what – the last thing you said.

MR. PATRICK: Oh, I'm sorry; Mr. Randolph needs to be a pain management system that works for him so that we can get him ready for trial.

We tried to explain to Naphcare that everything was fine until February when they changed. They're not listening to us. They're not listening to anybody, so while he's competent now, I think unless we get something changed to get him back on the medications that – you know, Dr. Roitman who has seen him several times, recommends he be on – and even Dr. Slagle, while finding him competent recommends he's on – recommends he goes back to the opioids. I have a strange feeling that we will probably be back here again.

But, with all that said, we have no challenge because I think it's – you know, it's – where we're at, is where we're at.

THE COURT: Do you have any response?

MR. PACE: I really don't. I guess we should just transfer it back to District Court, Department 23, who's in charge of the case and let them deal with the Defendant's medication issues for opioids. I've never seen opioids ever in a report-

THE COURT: Have a direct relationship to somebody's competency – MR. PACE: -- competence, yes.

THE COURT: -- so that's interesting. I think that Mr. Pace is right. I'm generally tasked with competent or not competent; and so I think this is something that could be raised and should be raised in front of department – what department did you say, 23?
