MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF AND APPENDIX

Appellant Clark County School District requests 30 days, through June 1, 2018, to file its opening brief and appendix. NRAP 31(b)(3). The brief in Docket No. 73856 was originally due February 20, extended by stipulation and motion to April 23. The brief in Docket No. 74566 was originally due April 2, extended by stipulation to May 2. This Court consolidated the two appeals on April 10, 2018 and set the deadline for the consolidated brief for May 2. This Court has not denied any requests for extension.

Counsel have completed the brief, but extraordinary circumstances necessitate additional time to coordinate its finalization and filing.

Undersigned counsel's wife and child fell ill at a time when it was im-

possible to reassign the brief to another attorney. That delayed completion of the brief, preventing lead appellate counsel from having an opportunity to review it; he is now out of the country at a conference. As the current version of the brief would require a request to exceed the word limit, the requested extension will also allow counsel to streamline the arguments to fit within that limit.

Finally, although counsel understand that, without other reasons, their caseload would not in itself justify the requested extension, counsel have had to deal with unexpected emergencies in several matters, including drafting a request for a temporary restraining order, seeking emergency post-judgment discovery in a case based on breaking news reports, and intervening in a case in which the court announced liability-concluding sanctions.

Counsel take seriously the requirement of extreme need and appreciate this Court's consideration of an extension under these extraordinary circumstances.
