Appellant Darrell T. Coker respectfully requests that the Court allow him to file a Request for Transcript of Proceedings pursuant to NRAP 9(a) despite the time do so having expired. The proposed request is attached as **Exhibit 1**. In its Order dated December 6, 2017, the Court instructed Mr. Coker to file and serve a transcript request form within 15 days of the Order, or December 21, 2017. Due to the holiday schedules of Mr. Coker's counsel, Mr. Coker was unable to file a timely transcript request with the Court.

NRAP 26(b)(1)(A) permits the Court "[f]or good cause" to "extend the time prescribed by these Rules or by its order to perform any act, or may permit an act to be done after that time expires." Mr. Coker's counsel did not intentionally fail to file the transcript request in a timely fashion, but rather was unable to do so because of their holiday travel schedule.

To ensure that this does not create any problems for the Court or scheduling of the appeal, on January 11, 2018 Mr. Coker submitted a transcript request of the proceedings in the district court below on an expedited basis. (*See* district court transcript request form, attached as **Exhibit 2**.) With this request, the district court reporter will prepare a transcript within 4 days of the request, or January 19, 2018. Pursuant to NRAP 9(c)(1)(A), the district court reporter is required to file the original transcript of the proceedings within 30 days of service of the transcript request form and deliver copies to the party ordering the transcript. Had

Mr. Coker filed the transcript request form on December 21, 2017 as ordered, the district court reporter would thus have had until January 22, 2018<sup>1</sup> to file an original transcript and provide copies.

Due to Mr. Coker seeking a transcript on an expedited basis, the district court will be able to satisfy its obligations under NRAP 9(c)(1)(A) within the same timeframe as if Mr. Coker had filed a transcript request form on December 21, 2017. There will thus be no harm to any party or to the Court's scheduling of this appeal by allowing Mr. Coker to file a transcript request form with this Court as required under NRAP 9(a)(1)(A).
