5	POINTS & AUTHORITIES

7	NRAP 14(4)(d) allows this Court to extend time for docketing
8	statements. The rule states:
9	(d) Extensions of Time. A motion for an
10	extension of time within which to file the
11	extension of time within which to me the
12	docketing statement will be granted for good
13	cause. Counsel's caseload generally will not
14	
15	provide grounds for an extension.
16	Based on the cyber-attack and Counsel's inability to recover his data, the

20 21	extension is adequate.
