MOTION FOR 5-DAY EXTENSION OF TIME

COMES NOW, Appellant, Richard Kilgore, by and through his counsel, Betsy Allen, Esq., and hereby files a motion for 5-day extension of time to obtain transcripts. This motion is based upon the following memorandum of points and authorities and all pleadings on file herein.

Memorandum of Points and Authorities

On December 20, 2017, Appellant filed Transcript Request Form. Parties conferred in accordance with NRAP 3E(c)(2)(A). Because of the extent of the subject-matter on appeal, the amount necessary for the preparation of the transcripts appeared to come to \$2800.00. Appellant did not exercise the 5-day

1 extension and filed a formal written motion requesting a more substantial
2 extension. *Motion for Extension of Time* filed February 27, 2018.

3 Upon granting the extension, Appellant raised the \$2800.00 for the deposit
4 on transcripts. *Notice of Compliance* filed March 12, 2018. Unfortunately, the
5 deposit fell short and Transcript Video Services informed Appellant that the total
6 costs were actually going to be \$4016.60. Exhibit 1.
7

8 This amount required Appellant to spend even more time raising funds.
9
10 Once paid, the transcripts were not made available until a solid month later. *Notice*
11 *from Court Reporter* filed April 9, 2018. Consequently, a good half of the time this
12 Court granted on extension was spent on raising funds for transcripts.
13

14 At this juncture, Parties have conferred on a Joint-Appendix, which has been
15 prepared with the exception of having been broken down into volumes and Bates
16 stamped. The opening brief is also half finished. Appellant need only a 5-day
17 extension to complete and file the appendix and brief, but the Clerk of this Court
18 cannot grant a NRAP 3E(f)(2) telephonic extension because a formal NRAP
19 3E(f)(3) extension was previously granted.

21 Accordingly, Appellant now requests from this Court a 5-day extension to
22 complete the transcript and brief.
