MOTION FOR EXTENSION OF TIME

Memorandum of Points and Authorities

13 Court's rejection of the appendices. The opening brief has been completed, but
14 existing rules do not allow its submission without a simultaneous submission of the
15 appendix. NRAP 30(e).
