

ORDER

On October 12, 2017, this court granted a temporary stay of execution of the district court's October 10, 2017, order denying petitioner's limited motion for a protective order and compelling production. We directed the parties to file any opposition and reply to the stay motion. In response, the parties have filed a stipulation that this Court should stay the production of Dorreen Whennen's notes pending this court's resolution of the petition. Cause appearing, we approve the stipulation.

Real party in interest has also filed a motion to redact and seal portions of the answer to the petition and to file under seal portions of the appendix. Cause appearing, the motion is granted. SRCR 3(4)(b). The clerk of this court shall detach from the motion filed November 1, 2017, the redacted answer to the petition and shall file it separately. The clerk shall file under seal the unredacted copy of the answer and volume 2 of the

appendix to the answer, both provisionally received in this court on November 2, 2017.

The stipulation of the parties extending the time for filing the reply in support of the petition, and the motion to redact portions of the reply and to submit an unredacted reply under seal are approved to the following extent. NRAP 31(b)(2). The clerk shall file the redacted reply and appendix received via E-Flex on November 20 and 21, 2017. Petitioner shall have 11 days from the date of this order to submit the unredacted reply. Upon receipt, the clerk of this court shall file the unredacted reply under seal.

It is so ORDERED.
