



*ORDER REGARDING TRANSCRIPTS AND DENYING MOTION FOR  
EXTENSION OF TIME*

Appellant has filed a notice stating that the trial transcripts requested from court recorder Kristine Santi have not yet been prepared and he will be unable to meet the current deadline for filing the opening brief.

Appellant served a transcript request form on court recorder Kristine Santi on December 15, 2017. In a notice filed with this court on February 9, 2018, counsel for appellant represents that she has not yet received the transcripts requested from Ms. Santi for proceedings conducted on August 28, 29, 30, and 31, 2017 and September 1, 2017. To date, Ms. Santi has not filed the notice of delivery required by NRAP 9(c)(2). A copy of the transcript request form is attached.

Ms. Santi shall have 20 days from the date of this order to: (1) file and deliver the requested transcripts as required by NRAP 9(c)(1)(A) and (2) file with this court the notice required by NRAP 9(c)(2). If Ms. Santi needs an extension of time, a motion as provided in NRAP 9(c)(4) must be filed within the same time period. If Ms. Santi believes that she is not responsible for producing the requested transcripts, she shall inform this

court in writing immediately. Failure to comply with this order may result in the imposition of sanctions. See NRAP 9(c)(5); NRAP 13.

Although the notice filed by appellant does not comply with the requirements for a motion for an extension of time, NRAP 31(b)(3), we elect to construe the notice as such. The motion is denied at this time. Appellant may renew the motion as the deadline for filing the opening brief and appendix approaches, if deemed necessary. Any renewed motion must comply with NRAP 31(b)(3). Failure to timely file the opening brief and appendix may result in the imposition of sanctions.

It is so ORDERED.




