12 IT IS HEREBY STIPULATED by and between all Parties to this appeal,
13 through their respective counsel of record, and pursuant to NRAP 26(b)(2), that the
14 remaining briefing deadlines are hereby extended as follows:

- 15 • The current deadline for all Respondents to file Answering Briefs, Thursday,
16 March 8, 2018, is hereby extended thirty (30) days to **Monday, April 9, 2018;**
- 17 • The current deadline for Appellant to file its Reply Brief is hereby extended to
18 be not less than forty-five (45) days from the date the last Respondent's Answering
19 Brief is filed, by in any case, no later than **Thursday, May 24, 2018.**
