ORDER

On October 16, 2017, this court granted a temporary stay of execution of the district court's order denying work product protection and compelling the production of certain notes. We directed the parties to file any opposition and reply to the stay motion. In response, the parties have filed a stipulation that the stay should extend through the resolution of the writ petition challenging the district court's order. Cause appearing, we approve the stipulation. The district court's October 31, 2017, order denying petitioner work-product protection and compelling production of the notes shall be stayed pending further order of this court.

Real parties in interest have filed a motion to file a redacted version of their answer to the petition for a writ of prohibition and to file an unredacted version under seal, and to file their appendix under seal. Real parties represent that the answer summarizes and discusses confidential matters that have been ordered protected by the district court pursuant to a protective order, and the documents in their proposed appendix include those documents. Cause appearing, the motion is granted. SRCR 3(4).

The redacted answer was inadvertently filed on November 1, 2017. Real parties shall have 11 days from the date of this order to submit the unredacted answer and the appendix. Upon receipt, the clerk of this court shall file the unredacted answer and the appendix under seal.

The stipulation of the parties extending the time for filing the reply in support of the petition is approved. NRAP 31(b)(2). The clerk of this court shall file the redacted reply received via E-Flex on November 21, 2017. Petitioner's motion to redact and seal portions of the reply is granted. The clerk of this court shall file under seal the unredacted reply received on November 29, 2017.

Petitioner has filed a motion to redact and seal a motion to strike real parties' appendix and to file the supporting declaration under seal. Real parties have filed a non-opposition to the motion to redact portions of the appendix and to seal the declaration and a countermotion to redact and seal portions of their response to the motion to strike and to seal their supporting exhibit. The motion and countermotion are granted. The clerk of this court shall detach the redacted version of the motion to strike portions of the appendix from the motion filed on November 13, 2017, and shall file it separately. The clerk shall file the unredacted version of the motion to strike received on November 14, 2017, under seal. The clerk shall

SUPREME COURT OF NEVADA detach the redacted version of real parties' response to petitioner's motion to strike portions of their appendix, attached to the response as Exhibit A to the response to the motion to redact and seal filed on November 21, 2017, and shall file it separately. Real parties shall have 5 days from the date of this order to submit the unredacted version of their response to the motion to strike portions of the appendix and their supporting exhibit. Upon receipt, the clerk of this court shall file the response and exhibit under seal.

Petitioner has filed a motion to redact and seal portions of her reply brief in support of her motion to strike the appendix filed by real parties in interest. Cause appearing, the motion is granted. NRAP 27(b). The clerk of this court shall detach the redacted version of the reply brief on motion to strike appendix from the motion to redact filed on November 30, 2017, and shall file it separately. The clerk shall file the reply brief on motion to strike appendix received on December 5, 2017, under seal.

It is so ORDERED.
