**NOTICE OF SUPPLEMENT TO
THE WYNN PARTIES' APPENDIX
AND UPDATED CITATIONS TO
RECORD**

On December 12, 2017, the Court entered an order denying Ms. Wynn's Motion to Strike the Wynn Parties' Appendix and corresponding portions of their Answer that cited to the Appendix. The Appendix contains excerpts from the "rough" transcript of Ms. Wynn's deposition dated October 26, 2017 (*see* Wynn Parties' App. 14-37) as the certified transcript from Ms. Wynn's deposition was not available on November 1, 2017 when the Wynn's Parties' Answer to the Writ Petition was due.

Concurrently with the filing of this Notice, the Wynn Parties have filed a Motion to Seal the Wynn Parties' Supplemental Appendix. The Supplemental Appendix contains the same substantive excerpts from Ms. Wynn's rough deposition transcript dated October 26, 2017 that were submitted as part of the original Appendix, but now those excerpts are from the certified copy of the deposition transcript. (*See* Supp. App. 38-63.) Because there is a slight difference in pagination between the rough version of the transcript and the certified version, the Wynn Parties wish to update the following citations to the record in their Answer:
