
## **SUPPLEMENT TO SETTLEMENT PROGRAM STATUS REPORT**

This is an unusual appeal in which the district court judge passed away after making certain rulings, but before entering rulings on some remaining issues. The case was assigned to a new judge, who has requested the parties to submit briefs in the district court, dealing with the status of the case and resolution of the remaining issues.

In the meantime, the parties participated in a Settlement Program settlement conference on December 15, 2017. After attempted negotiations, the parties all agreed (at the settlement judge's suggestion) to suspend the settlement conference until the new district judge has a chance to review the parties' briefs and issue further rulings in the case. We will be scheduling a status conference call in early March, 2018, in which the settlement judge and the parties will discuss the rulings by the newly-assigned district judge. We will also discuss whether to schedule a second session of the settlement conference.

Accordingly, the settlement conference proceedings are suspended at the present time, pending the conference call in early March of 2018.


