**MOTION FOR EXTENSION TO FILE
REQUEST FOR TRANSCRIPTS**

Appellant George Stuart Yount requests 30 days, until July 12, 2018, to file his transcript request. This is the second such request. Appellant previously obtained a 14-day telephonic extension. The request was originally due May 29, and without the extension, would be due June 12. No requests for extension have been denied or denied in part.
