MOTION FOR EXTENSION OF TIME TO FILE ANSWERING BRIEF

Respondent requests 30 days, through July 20, 2018, to file the answering brief. This is the second request for an extension, the first by motion. The original deadline of May 21, 2018 was extended by stipulation through June 20, 2018.

Additional time is needed to finalize the brief for filing. Respondent's counsel completed a draft brief taking into account the 75-volume, 17,599-page record on appeal. The requested extension is necessary, however, to allow counsel to coordinate with their client and ensure a streamlined presentation of the issues. For example, a detailed demonstration of the Grace Period Payments Deferment Agreement's operation in actual cases requires careful analysis and

mathematical computations. Undersigned counsel is also ensuring a comprehensive review, yet efficient presentation, of pertinent legislative history that will shed light on the statutory interpretation issues in this case and the role the administrative agency has played. The requested extension will allow respondent to address the issues in a way that will best assist the Court.
