6. Representation at district court - Petitioner/Appellant was represented during the trial litigation by counsel Bret Whipple and Patricia M. Erickson who was appointed.
7. Undersigned counsel is appointed to represent Mr. Cabrera during this appeal.
8. Ms. Cabrera was determined to be indigent in the district court and her financial circumstances have not changed.
9. Criminal information was filed in the district court on August 27, 2012.
10. This was a criminal case which resulted in a Judgment of Conviction after a jury trial and jury penalty hearing. The district court judge imposed the controlling sentences of life without the possibility of parole for two counts of First Degree Murder as determined by the jury. The sentences on the related crimes were ordered to run concurrently with the life without sentences. The convictions for two counts of First Degree murder with use of a deadly weapon, conspiracy to commit murder, burglary while in possession of a firearm and two counts of attempt murder with use of a deadly weapon will be challenged by this direct appeal.
