Real Parties in Interest Kazuo Okada, Universal Entertainment Corp., and Aruze USA, Inc. (collectively, "Defendants"), by and through their respective counsel of record, hereby give notice that they intend to oppose Wynn Resorts, Limited's Emergency Motion for Stay Under NRAP 27(e) Pending Disposition of Petition for Writ of Mandamus or Alternatively, Prohibition. As noted in the Emergency Motion, Wynn Resorts asks this Court to stay the entire case which, after almost 6 years of intense uninterrupted pretrial proceedings, is scheduled to be tried in less than four months, pending the Court's review of its discretionary writ petition regarding the district court's summary judgment ruling. On December 18, 2017, the district court denied Wynn Resorts' request to stay proceedings, and announced her decision to prepare for the upcoming trial by, among other things, having the Jury Commissioner send out jury duty notifications to approximately 10,000 potential jurors.

Defendants respectfully request the Court to refrain from ruling today on the Emergency Motion and allow them until close of business

tomorrow, December 20, 2017, to prepare and file their opposition to the Motion.
