**MOTION FOR EXTENSION OF TIME FO FILE**  
**NOTICE OF FILING REQUEST FOR TRANSCRIPT**

Appellant, Clark County Office of the Coroner/Medical Examiner (“Coroner”), by and through its attorneys of record, Marquis Aurbach Coffing and the Clark County District Attorney/Civil Division, hereby moves this Court pursuant to NRAP 26 for a 7-day extension of time to file its notice of filing request for transcript (“notice”).
