## **MOTION TO CONSOLIDATE APPEALS**

Appellant, Clark County Office of the Coroner/Medical Examiner (“Coroner”), by and through its attorneys of record, Marquis Aurbach Coffing and the Clark County District Attorney/Civil Division, hereby moves this Court to consolidate Supreme Court Case Nos. 74604 and 75095. Both appeals arise from the same District Court case, involve the same parties, and Case No. 75095 involves an order granting fees and costs, which was pending at the time Case No. 74604 docketed in this Court. As such, the issues of both appeals are interrelated, and the Coroner intends to include all documents in a single appendix and will address all issues in a single opening brief.

Based upon NRAP 3(b)(2), this Court should consolidate these two appeals for purposes of judicial economy. Briefing in appeal in Case No. 75095 has only recently been reinstated, and no briefs have been filed in either case. The needed transcripts for both appeals have already been ordered but have not yet been completed and delivered.

Because the Coroner intends to include all documents in a single appendix and prepare a single opening brief, it respectfully asks that this Court adopt the briefing schedule for Case No. 75095 for the consolidated case to allow sufficient time for review of the transcripts and completion of the appendix and opening brief.

Therefore, this Court should consolidate Supreme Court Case Nos. 74604 and 75095 with the deadline for the Coroner's opening brief and appendix on May 23, 2018. This motion is made in good faith and not for the purpose of delay.
