24 Upon consideration of Cristina Paulos's application to proceed in forma
25 pauperis and it appearing that there is not sufficient income, property, or
26 resources with which to maintain the action and good cause appearing
27 therefore:

28 IT IS HEREBY ORDERED that plaintiff Cristina Paulos shall be permitted to
proceed in forma pauperis with this action as permitted by NRS 12.015.

IT IS FURTHER ORDERED that Cristina Paulos shall proceed without the
prepayment of costs or fees or the necessity of giving security, and the Clerk of
the Court may file or issue any necessary writ, pleading or paper without
charge.

1 IT IS FURTHER ORDERED that the Sheriff or other appropriate officer
2 within this State shall make personal service of any necessary writ, pleading, or
3 paper without charge.


4 IT IS FURTHER ORDERED that if plaintiff Cristina Paulos prevails in this
5 action, the Court shall enter an order pursuant to NRS 12.015 requiring the
6 opposing party pay into the Court, within 5 days, the costs which would have
7 been incurred by the prevailing party, and those costs must then be paid as
8 provided by law.




