Appellant James J. Cotter, Jr. ("Cotter Jr.") hereby submits his status report in accordance with the Court's orders dated October 22, 2018 and July 23, 2018.

**A. Status of the proceedings below.**

On August 14, 2018, the district court entered its findings of fact and conclusions of law ("FFCL"), granting summary judgment in favor of the three remaining individual defendants on all Cotter Jr.'s claims.

Written notice of entry of the FFCL was served on August 16, 2018.

Thereafter the parties engaged in post-judgment motion practice relative to

costs and fees. The district court re-taxed defendants' claimed costs on October 1, 2018. The court denied defendants' motion for attorneys' fees on October 22, 2018. No written orders have been entered yet on these post-judgment decisions.

**B. Appeal No. 76981.**

Cotter Jr. appealed from the FFCL on September 13, 2018. On September 19, 2018, this Court issued a notice of referral to the settlement program and suspended briefing. On October 9, 2018, Appellant Cotter Jr. filed his docketing statement. The parties are currently scheduling mediation with the assigned settlement judge, Ara Shirinian, which is expected to occur in December 2018.

**C. Status of consolidation of the appeals.**

Cotter Jr. has prepared and expects the parties to shortly file a

joint motion to consolidate the two pending appeals (Case Nos. 75053 and 76981) under NRAP 3(b)(2).
