

The charges against Mr. Ketchum alleged in the Indictment arise from the September 25, 2016 shooting of Ezekiel F. Davis outside the Top Knotch Apparel on the 4200 block of South Decatur Boulevard. The State of Nevada charged Mr. Ketchum in a five (5) count Indictment together with co-defendants Antoine Bernard, Roderick Vincent, and Marlo Chiles as follows: (1) one count of murder with a deadly weapon; (2) one count of robbery with use of a deadly weapon; and (3) three counts of accessory to murder. Mr. Ketchum was only charged in the first two counts of the Indictment.

Jury trial began on May 23, 2017 and the jury returned a verdict of guilty on May 26, 2017 on (1) one count of murder with a deadly weapon; and (2) one count of robbery with use of a deadly weapon. Mr. Ketchum was sentenced on February 5, 2018. Mr. Ketchum filed a timely appeal of the district court's judgment on February 6, 2018.

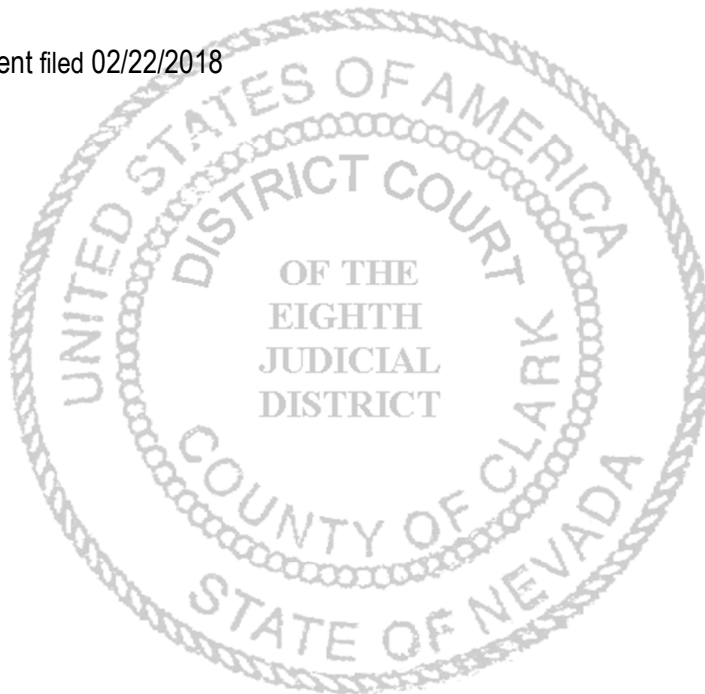
