RESPONDENT'S LIMITED JOINDER TO APPELLANT'S MOTION TO POSTPONE ORAL ARGUMENT

Zitting Brothers Construction, Inc. ("Zitting") respectfully submits this limited joinder to APCO Construction, Inc.'s motion to postpone oral argument. Zitting agrees with APCO Construction, Inc. ("APCO") that it would be best to

postpone the oral argument currently scheduled for June 11, 2020. However, Zitting has two concerns with any postponement.

These concerns involve potential prejudice to Zitting from any postponement. First, APCO may stop maintaining the appellate bond for the judgment amount after June 11, 2020. Second, APCO may argue that the continuance would stay the accruing post-judgment interest. During its discussions with Zitting regarding those concerns, APCO has represented that it will maintain the appellate bond for the duration of the appeal and that interest accrued on Zitting's judgment amount, if awarded, would be protected. Zitting understands this to mean that APCO would not argue that the postponement of the oral argument would not affect the accruement of the judgment interest. In reliance on APCO's representations and Zitting's understanding, Zitting joins APCO's motion to postpone oral argument.
