



- Having considered Defendant's Motion to Compel Production of Discovery and Brady Material, this Court notes there is no indication the parties have met and conferred concerning the discovery requests, and many of the requests are vague. This Court requires parties in making discovery motions to include an affidavit of counsel verifying the parties met and conferred regarding discovery and identifying the specific issues which remain unresolved. Defendant's counsel did not provide such an affidavit. Consequently, the Court issues its standard ORDER and requires the State to produce all discovery materials to defendant before trial as required by Nevada Revised Statutes, in particular NRS 174.233 to 174.295, inclusive, all exculpatory and witness impeachment evidence or information as required by Brady v. Maryland, 373 U.S. 83 (1963) and Giglio v. United States, 405 U.S. 150 (1972) and their progeny, and any other evidence or information required to be disclosed pursuant to applicable State of Nevada or federal appellate court opinions. The State has a continuing duty to disclose promptly any additional discovery materials which come to the attention of the State.

If Defendant or the State believes they are entitled to discovery which a party has not provided, counsel for the parties shall meet and in good faith confer regarding their discovery disputes. If disputes still remain, a party may then file a discovery motion with the Court including an affidavit of counsel stating when and where the parties met and conferred and specific nature of the discovery

remaining in dispute. The Court will then consider the party's motion and points and authorities related to the specific discovery issue. Therefore, COURT ORDERED, hearing date of 10/24/17 is VACATED and matter taken OFF CALENDAR.
