And our potential witness is Ana Nellis. 8 THE COURT: Ladies and gentlemen, we are about to 9 commence examination of potential jurors in this case. During this 10 11 process, you will be asked questions bearing on your ability to sit as fair and impartial jurors. The Court, the lawyers, and all persons 12 involved in this case are interested in having this matter tried by a 13 jury composed of 12 open-minded people, who are completely 14 neutral, and who have no bias or prejudice towards either side. 15 In this trial, we will also need two alternate jurors to listen 16 to all the proceedings and be prepared to take over as a juror in the 17 event a sitting juror is excused. In order to accomplish this, it is 18 necessary for me to ask some questions. The attorneys will then be 19 given the opportunity to ask questions. 20 Although some of the questions may, at times, seem quite 21 personal, our only objective is to determine whether there is any 22 reason why any of you cannot sit as a fair and impartial juror in this 23 case. If a question seems too personal to you, you can raise your 24 hand and ask us to talk to you privately. But understand that your 25

1 answers will have to be on the record.

2 It is very important that you give full, complete, and honest 3 answers to all of the questions we are about to ask you. I caution you 4 not to try to hide or withhold anything which might indicate bias or prejudice of any sort by any of you. Should you fail to answer 5 truthfully or if you hide or withhold anything touching upon your 6 7 qualifications, that fact may tend to contaminate the verdict and 8 subject you to further inquiry, even after you are discharged as jurors. Your decision should not be based upon -- your decision should be 9 based upon all the evidence presented during the trial and not based 10 11 upon preconceived prejudice or bias.

During this process of selecting a jury, the attorneys for both sides will have the right to request a particular -- that a particular person not serve as a juror. These requests are called challenges. Please do not be offended should you be excused by a challenge. This is simply part of the process designed to protect the rights of the parties.

The questioning of potential jurors at the beginning of the 18 case is done under oath. But before the clerk issues the oath to you, I 19 need to know if any of you are not citizens of the United States or if 20 any of you are convicted felons whose civil rights have not been 21 restored. To be qualified to serve as a juror, one must be a citizen 22 and not be a convicted felon whose rights have not been restored. 23 Please raise your hand if you are not a citizen or if you are 24 a convicted felon whose rights have not been restored. 25

6	before coming to court today? Let the record reflect no response to
7	that question.
8	Does anyone know anything about this case other than
9	what has been stated in court in the courtroom today? Let the
10	record reflect no response to that question.
11	Is there anyone who has such strong opinions relating to
12	age, religion, race, gender, or national origin that they feel would
13	affect their ability to be open minded, fair, and impartial jurors?
14	Again, let the record reflect no response to that question.
15	Is anyone here seriously ill? Let the record reflect no
16	response to that question.
17	Is there anyone here who has difficulty hearing?

3	PROSPECTIVE JUROR NO. 325: Nobody else can take care
4	of her after.
5	THE COURT: And would you mind telling me what the
6	handicap is, sir?
7	PROSPECTIVE JUROR NO. 325: Can't hear. She can't talk.
8	THE COURT: Okay. And do you have somebody who is
9	able to pick her up today?
10	PROSPECTIVE JUROR NO. 325: Right now, yeah.
11	THE COURT: Okay. And that would cause extreme
12	hardship for your daughter if you were to sit as a juror in this case? Is
13	that a yes or no, sir?
14	PROSPECTIVE JUROR NO. 325: No.
15	THE COURT: It would not or would cause extreme
16	hardship on your daughter if you were to sit as a juror in this case?
17	PROSPECTIVE JUROR NO. 325: Yes, sir.
18	THE COURT: Okay. And I apologize. What was your
19	name, sir?
20	PROSPECTIVE JUROR NO. 325: Rene Artiga.
21	THE COURT: Thank you, sir.
22	Under our system, certain basic so oh, I'm sorry. I
23	apologize.
24	And could you please state your name and your badge
25	number?

1	PROSPECTIVE JUROR NO. 371: Arturo Pin, Badge 371.
2	THE COURT: And, sir, what is your extreme hardship?
3	PROSPECTIVE JUROR NO. 371: English is my second
4	language, so I don't speak completely English.
5	THE COURT: Okay.
6	PROSPECTIVE JUROR NO. 371: So
7	THE COURT: You would I expect the testimony today to
8	be in English. And it would be difficult for you to follow along in
9	English; is that what you are advising me?
10	PROSPECTIVE JUROR NO. 371: Yeah. Yes, it is. It might
11	be words that I'm not used to speak or understand, so I think for this
12	trial it would be difficult for me.
13	THE COURT: Okay. Anything else, sir?
14	PROSPECTIVE JUROR NO. 371: No.
15	THE COURT: Thank you.
16	PROSPECTIVE JUROR NO. 390: Katherine Doty, Badge
17	390.
18	THE COURT: Yes, ma'am.
19	PROSPECTIVE JUROR NO. 390: It's actually not an extreme
20	hardship for myself. I'm corporate treasurer of Classic Door & Trim. I
21	process the payroll, and I have since 1982 for 70 employees every
22	week. If we're done by Thursday at 4 o'clock, I'm going to be good. I
23	have to have payroll out at 7:30 in the morning for the employees.
24	No one else does it. So
25	THE COURT: Okay. And so you have to have your payroll

1 done by 4 o'clock?

PROSPECTIVE JUROR NO. 390: No. I disburse it at 7:30 on
 Friday morning. So --

THE COURT: Okay. And this is only going to be a two- or
three-day trial. Is that going to interfere with your ability to perform
your job?

PROSPECTIVE JUROR NO. 390: That's what I just want to
let you know, I just would have to be, you know, done so I could get
payroll done on Thursday afternoon at the latest. Yeah, so it's -- it
should be okay if it's two or three days. It's just -- I just wanted to let
you know that.

THE COURT: I appreciate that. And I'm hopeful this will
only be a two- or three-day trial, but sometimes it goes a little longer.
I can't make you any guarantees.

PROSPECTIVE JUROR NO. 390: Right. That's what I just
wanted to make sure. I have 70 people that get a paycheck every
Friday morning, and I'm the only one that does it.

24THE COURT: And what is your extreme hardship, sir?25PROSPECTIVE JUROR NO. 414: It's -- I think it's the same

1	situation like the guy. Many words are just too hard to understand.
2	THE COURT: Okay. Is what is your native language, sir?
3	What is your native language?
4	PROSPECTIVE JUROR NO. 414: Spanish.
5	THE COURT: Okay. And English is a second language?
6	PROSPECTIVE JUROR NO. 414: Yeah. But I speak just a
7	little not many.
8	THE COURT: You speak just a little English?
9	PROSPECTIVE JUROR NO. 414: Yes.
10	THE COURT: Okay. And is what you're explaining to me
11	is that you may not understand some of the testimony if it's in
12	English?
13	PROSPECTIVE JUROR NO. 414: Sorry. I I don't I don't
14	understand what you says.
15	THE COURT: Okay. If the if the witnesses testify in
16	English, which I expect them to do, are you telling me that it will be
17	difficult for you to understand the testimony?
18	PROSPECTIVE JUROR NO. 414: Yes.
19	THE COURT: Anything else, sir? Is there anything else?
20	PROSPECTIVE JUROR NO. 414: No, no. That's it.
21	THE COURT: Thank you.
22	PROSPECTIVE JUROR NO. 414: Thank you, sir.
23	PROSPECTIVE JUROR NO. 369: Your Honor, Badge
24	No. 369, Josephine Cervantes. You just said that it might take more
25	than three days.

1	THE COURT: It's expected to last two or three days.
2	PROSPECTIVE JUROR NO. 369: Okay. If it takes more than
3	that, then because I had I'm having more surgery on the 7th, and I
4	cannot cancel that, so
5	THE COURT: Okay. What kind of surgery are you having?
6	PROSPECTIVE JUROR NO. 369: I'm going through cancer,
7	and I'm having jaw reconstruction right now, and I'm having a biopsy
8	next week for my cancer, so
9	THE COURT: Okay. And you have surgery on
10	November 7th?
11	PROSPECTIVE JUROR NO. 369: That's a biopsy for my
12	lungs.
13	THE COURT: Okay. And it
14	PROSPECTIVE JUROR NO. 369: So I would like to serve,
15	but just not on those days when I have to have my surgeries
16	THE COURT: Sure.
17	PROSPECTIVE JUROR NO. 369: or doctor appointments.
18	THE COURT: No, I understand. So your biopsy is
19	November 7th.
20	PROSPECTIVE JUROR NO. 369: November 7th.
21	THE COURT: And when is your surgery?
22	PROSPECTIVE JUROR NO. 369: For my oral is
23	November 7 November 17.
24	THE COURT: Okay. But the biopsy is November 7?
25	PROSPECTIVE JUROR NO. 369: On the 7th, yes.

1	THE COURT: Okay. Anything else, ma'am?
2	PROSPECTIVE JUROR NO. 369: No, no. Just wanted to let
3	you know. Thank you.
4	THE COURT: All right. Thank you so much.
5	Anybody else?
6	Okay. I want to advise you under our system certain basic
7	principles of law apply in every criminal trial. They are that the
8	defendant is presumed innocent and the State has the burden of
9	proving beyond a reasonable doubt that the defendant is guilty.
10	Does anyone not believe in these basic principles of
11	American justice? Let the record reflect no response to that question.
12	There is one more thing I need to mention to everybody as
13	a group. Under the law, if you are selected to serve as a juror, you
14	will be required to decide the facts of the case. In making your
15	decision, however, you must be guided by the laws that applies to the
16	facts. It will be my duty to instruct you on what the law is. So my
17	question to all of you is this: Is there anybody who will not be able to
18	follow the law if you believe the law should be different than what I
19	tell you? Let the record reflect no response to that question.
20	Counsel approach.
21	[Bench conference was had and transcribed as follows:]
22	THE COURT: I'm just going to excuse the jurors who
23	[indiscernible] undue hardship and [indiscernible].
24	MR. LEXIS: Why don't we just do it right now?
25	THE COURT: That's fine.

1	MR. LEXIS: [Indiscernible.]
2	THE COURT: Hold on a second. Can you get
3	[indiscernible]? Have my marshal come over here.
4	I need you to stand in front of the jurors to make sure they
5	can't hear the bench conference. If they can, let me know, and then
6	I'll have to excuse them.
7	MR. LEXIS: Do you have any objection to the two
8	non-English speakers?
9	THE COURT: All right. So we have two people with
10	children and one with older children who is handicapped. We have
11	two people who are representing that they thank you. You have to
12	excuse me. I apologize. I can't believe that they can hear me.
13	MS. BONAVENTURE: Yeah.
14	THE COURT: Okay. I'm just going to do this, I'm just going
15	to have them go outside.
16	MS. BONAVENTURE: Okay.
17	MR. LEXIS: That's fine.
18	THE COURT: It'll just take two seconds.
19	MS. BONAVENTURE: Sure.
20	[Bench conference was concluded.]
21	THE COURT: Amazingly, most of the time people can't
22	hear me, but apparently at the bench conference, I can't speak low
23	enough that you can slightly hear me. So what I'm going to ask,
24	ladies and gentlemen, is I'm going to excuse you. If you could just
25	wait outside in the hallway, and that way I can discuss some matters

1 with the attorneys. It'll only take a few minutes.

2 [Outside the presence of the proposed jury panel.] 3 MR. LEXIS: Your Honor, the only people I think should be 4 let go are the two people that stay they can't understand, because I don't want to go through this whole trial and then at the end say they 5 have no idea what was happening for the last two days, and the 6 person who said that the -- their child is handicapped. 7 But if defense counsel wants to object to that one, that's 8 fine. Then we could keep them too. But I think everyone else should 9 10 stay. 11 THE COURT: And what's the State -- the defense position? MS. BONAVENTURE: Will, quite honestly, Your Honor, we 12 have no problem with any and all of them being dismissed. I 13 understand the hardships of the kids, especially the young lady with a 14 six-month-old at home. I think it would, from personal experience, 15 create a person -- a substantial hardship for her to have her 16 two-year-old and six-year-old [*sic*] having to be taken care of by 17 people that she doesn't really know just to be here. I know her 18 mind's probably going to be there. 19 On top of the guy, Salvatore Tatti, who has only picked 20 up -- temporary custody of his son, I believe his mind is also going to 21 be on his son and his upcoming work trip that is scheduled for 22 Monday. So we do not have a problem with him being excused. 23

I agree with the State, Rene Artiga, who has the daughter
with -- who is mute and deaf, I believe we can dismiss him by

1 agreement.

23

2 As far as the Spanish speakers, Your Honor, obviously 3 there's a varying degree to which they can understand. If Your Honor 4 wants to excuse them, we're fine with that. However, if Your Honor wants to see if we even get to them or give them -- give us more of 5 an opportunity to cross-examine whether or not they actually do 6 7 speak a little bit more or understand a little bit more than they think 8 they do, I would be amenable to that as well, seeing as it should not be a handicap to them doing their duty as a juror, especially since 9 they are probably immigrants. I think it's an important activity for 10 11 them to partake in and that language should not be a barrier to that.

As far as the payroll clerk, Judge, I wouldn't usually see that as a hardship, but if -- the DA has indicated in chambers earlier that he believes we might be going -- we might still be doing witness testimony on Thursday, so I'll leave that up to Your Honor. We wouldn't object to her being dismissed if Your Honor thought that a sufficient hardship.

And I -- oh, and the young gentleman who has a hearing
problem, I think that might be taken care of by him.

THE COURT: I don't think he was asking to be excused
 under hardship. I think he was just advising me that he had a hearing
 issue.

MR. LEXIS: Your Honor, the one -- the treasurer, that -doing the payroll, that's absolutely no excuse. A lot of people got

MS. BONAVENTURE: Oh, okay. Okay.

1	jobs. Just because she's trying to say, Oh, I have they're relying on
2	me. She's got the morning to do it. In addition, that's just not a
3	hardship. That's the first words out of her mouth, it's not a hardship.
4	THE COURT: Okay.
5	MR. LEXIS: And as far as these other ones that's the single
6	mom and the other one, they're I'm sure that there's many people
7	in this courtroom that is sucking it up as single parents to serve.
8	They shouldn't be punished just because they're not speaking up.
9	THE COURT: All right. What about what's your position
10	on the people who I do have a concern about the individuals that
11	don't speak English fluently, that it's a second language.
12	MS. BONAVENTURE: Well, Your Honor, I understand your
13	concern. However, they do speak English. They were both speaking
14	English, in fact, for the record, and they both actually were speaking
15	very well. I believe only one gentleman really had a problem
16	understanding what you were saying, the gentleman all the way in
17	the back. And even when you I don't know if it was a problem with
18	him understanding or whether it was him hearing you.
19	THE COURT: Uh-huh.
20	MS. BONAVENTURE: So as far as them
21	THE COURT: So what is your recommendation on the
22	people? What I'm going to do
23	MR. LEXIS: Are you asking the State, Your Honor?
24	MS. BONAVENTURE: I'm sorry. On the people I'm sorry.
25	I was thinking what I want to do. My inclination is to let the two

parents go -- the one with the 6-month-old child, the one that has
visitation, and the -- well, I guess there's three parents -- the one that
has the handicapped child.

As far as the woman that has surgery, I'm going to just
keep her on for right now, just to see -- I may let her go if after we get
a little farther into this, because if we are going to go to Friday, you
know, I'll probably have to let her go. I'm not going to make her miss
her biopsy.

9 As to the person on the payroll at this point, I agree. I don't
10 think that's an undue hardship.

I am going to keep the two people to allow you to voir dire
them at this point. I'm going to reserve ruling on whether it
constitutes an undue hardship at this point. So the people -- whether
the -- I want to make sure we all agree on the people that -- what are
the -- what are the names and badge numbers of the people who are
going to be -- okay. So it's the three parents.

THE CLERK: Right.

11	English, my inclination will be to excuse them for undue hardship.
12	MS. BONAVENTURE: And just to clarify, that's Mr. Arturo
13	Pin, Badge No. 371, and Rene oh, no, that we dismissed him.
14	THE COURT: And who is the other one the other
15	gentleman?
16	MR. HAUSER: I got it. Badge No. 414, Martin Garcia.
17	MS. BONAVENTURE: Yeah. Martin Garcia, Badge 414.
18	THE COURT: Okay. So understand, Counsel, I'm not going
19	to require a challenge for cause to excuse them. I reserve ruling on
20	whether they are an undue hardship, only because you requested
21	voir dire to establish if they understand. But if I'm not convinced that
22	they fully understand the English language, I am going to excuse
23	them as an undue hardship.
24	Do you have any issue with that?
25	MS. BONAVENTURE: No, Your Honor. I have no issue

1 with that.

1	with that.
2	THE COURT: Okay. And then the person that has surgery,
3	depending on whether she is called to the box or not, I'm going to ask
4	some further questions of counsel outside the presence of the jury
5	whether they think this case is going to go beyond Thursday.
6	MR. LEXIS: Your Honor, I she said her surgery is on the
7	7th, and the 7th isn't until next Tuesday. So there's no
8	THE COURT: And she actually seemed to indicate she was
9	willing to serve, she just didn't want to miss the biopsy, so

17	with the payroll. I'll advise her that we'll probably but I don't think I
18	need to advise her right now.
19	MR. HAUSER: Okay. Just in case.
20	THE COURT: Yeah. I don't think it's an issue. But that is a
21	good point, I think, that you raised.
22	MR. HAUSER: It might help, but other than that, I
23	THE COURT: Okay. I'm excusing Badge No. 298, Badge
24	No. 324, and Badge No. 325 for undue hardship. Okay?
25	MR. HAUSER: Sounds good.

1	MS. BONAVENTURE: Great.
2	MR. HAUSER: Thank you, Your Honor.
3	THE COURT: And I'm reserving ruling on Badge No. 371
4	and Badge No. 414 to give you the opportunity to voir dire them
5	MR. HAUSER: Thank you, Your Honor.
6	THE COURT: unless you want to ask questions now. I
7	mean, would you rather ask questions now or wait to see if they get
8	picked and [indiscernible]?
9	MS. BONAVENTURE: Well, we can wait to see if they even
10	make it in the box, Judge.
11	THE COURT: Okay.
12	MS. BONAVENTURE: Yeah.
13	THE COURT: Very good. Why don't you bring the panel
14	back in?
15	Counsel, Mr. Allen, please be seated.
16	Hi, ma'am. Ma'am, hi. Could you identify yourself, please?
17	PROSPECTIVE JUROR NO. 418: Sandra Oceguera.
18	THE COURT: What's your badge number?
19	PROSPECTIVE JUROR NO. 418: 418.
20	THE COURT: And were you present during any of the
21	questions I asked the panel?
22	PROSPECTIVE JUROR NO. 418: No.
23	THE COURT: The panel has been sworn under oath, so I
24	need to ask you some questions before I swear you under oath. Then
25	I need to ask you questions I asked the entire panel to hear your

1	responses on the record; okay?
2	PROSPECTIVE JUROR NO. 418: Okay.
3	THE COURT: Before the clerk issues the oath to you, I need
4	to know if you are not a citizen of the United States or if you are a
5	convicted felon for the whose civil rights have not been restored.
6	To be qualified to serve as a juror, one must be a citizen and not be a
7	convicted felon whose rights have not been reserved [ <i>sic</i> ]. Are you a
8	U.S. citizen?
9	PROSPECTIVE JUROR NO. 418: Yes.
10	THE COURT: Are you a convicted felon
11	PROSPECTIVE JUROR NO. 418: No.
12	THE COURT: whose rights have not been restored?
13	PROSPECTIVE JUROR NO. 418: No.
14	THE COURT: Okay. At this time, I am going to have the
15	clerk administer the oath.
16	[Prospective juror was duly sworn.]
17	THE COURT: I need to introduce my court staff to you.
18	Robin Page is the official court recorder. Alan Castle is the deputy
19	court clerk. Randy Stephenson is the marshal. Allen Brereton and
20	the law clerk. And Shannon Fagin is my judicial executive assistant.
21	I'm going to have the State introduce themselves and the
22	potential jurors [ <i>sic</i> ] and make a brief statement to you.
23	MR. LEXIS: Ma'am, my name is Chad Lexis. This is Laura
24	Rose. We're deputy district attorneys at the Clark County District
25	Attorney's Office. We represent the State.

His name is Robson 16 Hauser, and that's our law clerk, Jane Mayer. 17 Mr. Ronald Allen stands accused. 19	PROSPECTIVE JUROR NO. 418: No.
20	THE COURT: Have you heard or read anything about this
21	case before coming to court today?
22	PROSPECTIVE JUROR NO. 418: No, I don't think so.
23	THE COURT: Does anyone know anything about this do
24	you know anything about this case other than what you been stated
25	in the courtroom today?

1	PROSPECTIVE JUROR NO. 418: No.
2	THE COURT: Is there anyone who or do you have such a
3	strong opinion related to age, religion, race, gender, or national origin
4	that you feel it would affect your ability to be an open-minded, fair,
5	and impartial juror?
6	PROSPECTIVE JUROR NO. 418: No.
7	THE COURT: Okay. Are you seriously ill?
8	PROSPECTIVE JUROR NO. 418: No.
9	THE COURT: Do you have any difficulty hearing?
10	PROSPECTIVE JUROR NO. 418: No.
11	THE COURT: Are you sight impaired?
12	PROSPECTIVE JUROR NO. 418: No.
13	THE COURT: And you've already told me you're not a
14	convicted felon; correct?

19	gospel.
20	PROSPECTIVE JUROR NO. 281: Correct.
21	MR. LEXIS: Okay. You're to wait and judge his credibility
22	and see if what he is saying is reasonable and makes sense.
23	PROSPECTIVE JUROR NO. 281: That's correct.
24	MR. LEXIS: Are you going to be able to do that?
25	PROSPECTIVE JUROR NO. 281: Yes.

1	MR. LEXIS: Or are you going to I say State calls Officer
2	Smith. And you're automatically going to be like, oh, whatever
3	Officer Smith is saying, I'm going to take as gospel. I don't care if it
4	doesn't make sense or is not reasonable.
5	PROSPECTIVE JUROR NO. 281: I would be able to, for the
6	last ten years, working for the Wynn, I was responsible for
7	investigating many cases which resulted in terminations and
8	nonterminations. So I actually was in a judging type of position to
9	look at all the evidence and put the evidence together
10	MR. LEXIS: Okay.
11	PROSPECTIVE JUROR NO 281: [indiscernible]
12	terminations.
13	MR. LEXIS: And some security guards over there probably
14	got fired as well.
15	PROSPECTIVE JUROR NO. 281: Not within my jurisdiction.
16	MR. LEXIS: But you would agree that it's possible; right?

2	Juror 309, down here at the bottom.
3	PROSPECTIVE JUROR NO. 309: Yes.
4	MR. LEXIS: Sir, I'm sure you understand why I'm the
5	mike is back at you; correct?
6	PROSPECTIVE JUROR NO. 309: I do, sir.
7	MR. LEXIS: Okay. And in your own words, do you
8	understand what I'm saying?
9	PROSPECTIVE JUROR NO. 309: I do, sir.

22	assaulted me was a prostitute. And she was high I mean, she was	
23	drunk or something like that. So	
24	MR. LEXIS: Okay. And you previously heard the questions	
25	about being fair and impartial?

3	cannot be fair and impartial because of that incident?
4	PROSPECTIVE JUROR NO. 341: Correct.

6	probably most people in this room have had some life experiences
7	I'm not saying the same exact thing, but situations in their past where
8	it's going to affect them for the rest of their life and they're never

22	assault for me. You don't touch anybody.

2	too cloudy for me right now to even go there. Like, I just don't want
3	to even go want to go visit that part of my life.

5	that you think is out there that I should know about, as far as being
6	fair and impartial?
7	Thank you very much.

5	MS. BONAVENTURE: Okay. Okay. So you believe you'd
6	be fair and impartial?
7	PROSPECTIVE JUROR NO. 260: Yeah.
8	MS. BONAVENTURE: Okay. Fantastic.
9	Let's see. Thank you. So, Ms. Gayhart, you said you're a
10	supervisor?
11	PROSPECTIVE JUROR NO. 261: Yes.
12	MS. BONAVENTURE: What kind of super what
13	PROSPECTIVE JUROR NO. 261: Table games.
14	MS. BONAVENTURE: Oh, table games.
15	PROSPECTIVE JUROR NO. 261: Uh-huh.
16	MS. BONAVENTURE: Okay. I think it was really hard for us
17	to understand what you you said big supervisor?
18	PROSPECTIVE JUROR NO. 261: Was I whispering? I said
19	pit.
20	MS. BONAVENTURE: Oh, pit supervisor.
21	PROSPECTIVE JUROR NO. 261: Uh-huh.
22	MS. BONAVENTURE: Okay. That makes a lot more sense.
23	Okay. I wanted to clarify that. You're originally from Germany.
24	PROSPECTIVE JUROR NO. 261: I'm originally from
25	Romania, went to college in Germany, and then lived here for

2	MS. BONAVENTURE: Okay. What did you what you
3	were you educated in in Germany?
4	PROSPECTIVE JUROR NO. 261: In foreign language
5	correspondent.
6	MS. BONAVENTURE: Okay. So you have no problems
7	with the English language?
8	PROSPECTIVE JUROR NO. 261: Not at all.
9	MS. BONAVENTURE: Okay. I just wanted to double check
10	that because it's nice to be [indiscernible].
11	PROSPECTIVE JUROR NO. 261: Of course.
12	MS. BONAVENTURE: Okay. Let's see. Mr. Paul, so you
13	said you have lots of kid or I wrote that you have lots of kids.

15	MS. BONAVENTURE: How many? Four?

2	MS. BONAVENTURE: Okay. Let's see. And you're a new
3	grandparent, so congratulations, right?
4	PROSPECTIVE JUROR NO. 272: Yes. Thank you. Yeah.
5	MS. BONAVENTURE: I had that also. And you're oh,
6	your spouse works for the libraries. And you're a supervisor for Cox
7	Communications.
8	PROSPECTIVE JUROR NO. 272: Cox Communications, yes.
9	MS. BONAVENTURE: Okay. Okay. Is there anything that
10	you think would make it unfair or make you unable to be an
11	impartial juror?
12	PROSPECTIVE JUROR NO. 272: No, not at all.
13	MS. BONAVENTURE: No? Okay. Good. Okay. Perfect.
14	Ms. Hazlett?
15	PROSPECTIVE JUROR NO. 273: Uh-huh.
16	MS. BONAVENTURE: Okay. So you said your uncle has
17	been in the system quite a bit?
18	PROSPECTIVE JUROR NO. 273: Oh, yeah.

7	really do you have an overall negative view of maybe somebody
8	who is being accused of a crime?
9	PROSPECTIVE JUROR NO. 273: No.
10	MS. BONAVENTURE: No? Okay. So you would be able to
11	be fair and impartial?
12	PROSPECTIVE JUROR NO. 273: Yes.
13	MS. BONAVENTURE: Okay. So in your view, as
14	Mr. Ronald Allen sits there, is he innocent or guilty?
15	PROSPECTIVE JUROR NO. 273: We don't know yet.
16	MS. BONAVENTURE: Well, he's actually
17	PROSPECTIVE JUROR NO. 273: He's innocent, yes.
18	MS. BONAVENTURE: Exactly. He's actually innocent as he
19	sits there; right?
20	PROSPECTIVE JUROR NO. 273: Right. Innocent until
21	proven guilty, yes.
22	MS. BONAVENTURE: So exactly. And it's proven guilty
23	beyond a reasonable doubt; right?
24	PROSPECTIVE JUROR NO. 273: Uh-huh.
25	MS. BONAVENTURE: So the State's burden, because he

1	sits there innocent, their burden is to prove that he is 100 percent
2	guilty, beyond a reasonable doubt guilty.
3	PROSPECTIVE JUROR NO. 273: Uh-huh.
4	MS. BONAVENTURE: We've all seen it on TV. Beyond a
5	reasonable doubt he was guilty of the crime he's been accused of;
6	correct?
7	PROSPECTIVE JUROR NO. 273: Uh-huh.
8	MS. BONAVENTURE: So that's exactly what they have to
9	prove. Okay. And you don't because you have a family member
10	with a criminal history, you don't just prejudge him; right?
11	PROSPECTIVE JUROR NO. 273: No.
12	MS. BONAVENTURE: Just because you're accused of
13	something doesn't mean that you've done what you've done unless
14	they can provide proof; correct?
15	PROSPECTIVE JUROR NO. 273: Right.
16	MS. BONAVENTURE: Okay. All right. And your best
17	friend's husband is an LVMPD officer?
18	PROSPECTIVE JUROR NO. 273: My mom's friend's
19	husband.
20	MS. BONAVENTURE: Your mom's friend's husband.
21	Okay.
22	PROSPECTIVE JUROR NO. 273: But I've babysat for them
23	for four years, so
24	MS. BONAVENTURE: Okay. How long ago was that?
25	PROSPECTIVE JUROR NO. 273: Four years ago.

MS. BONAVENTURE: Oh, okay. So you don't really have
any interaction with them?
PROSPECTIVE JUROR NO. 273: Not as much, no.
MS. BONAVENTURE: Okay. And there's nothing no
conversation, nothing negative in that
PROSPECTIVE JUROR NO. 273: No.
MS. BONAVENTURE: those communications that would
make you not impartial?
PROSPECTIVE JUROR NO. 273: No.
MS. BONAVENTURE: All right. Thank you.
THE COURT: Counsel, could you approach the bench?
MS. BONAVENTURE: Yes.
[Bench conference was had and transcribed as follows:]
THE COURT: Randy, can you stand over by the jury? I'm
going to it's 4:30.
MS. BONAVENTURE: Uh-huh.
THE COURT: It's obvious to me we're not going to get a
jury today. So I'm going to let you continue your voir dire.
[Indiscernible] the challenges for cause. So we can
MR. LEXIS: Judge, I would ask that we go right up until
5:00, so
THE COURT: No. We're going to go right up till 5:00. But
it's obvious to me
The other thing I wanted to point out to you, the people in
the front row, you're so close to them, they don't know where to

1	look
2	MS. BONAVENTURE: Oh.
3	THE COURT: because you're right in front of them.
4	MS. BONAVENTURE: Okay. Well, I'm sorry.
5	THE COURT: I mean, they're [indiscernible]. So you might
6	want to just give them, like, about two feet, three feet.
7	MR. HAUSER: And I think we might [indiscernible] zero
8	mar has only been up there ten minutes [indiscernible].
9	MS. BONAVENTURE: Yeah. I'm, like, halfway through.
10	MR. HAUSER: We're speeding through it, but
11	THE COURT: No. I think you're right. We'll probably get
12	the challenges for cause, but then I've got to reseat people, go over
13	the questions. So we're not going to get a jury today, I'm pretty sure.
14	But we'll [indiscernible] at least until 5 o'clock.
15	But I also wanted to point out to you, I'm looking at their
16	faces, and the people you're only about a foot away from them,
17	so
18	MS. BONAVENTURE: Oh, okay.
19	THE COURT: they don't know where to look.
20	MS. BONAVENTURE: Okay.
21	THE COURT: And you know, they're
22	MS. BONAVENTURE: Down.
23	THE COURT: look at your belly, yeah, yeah.
24	MS. BONAVENTURE: Yeah.
25	THE COURT: You know, I'm just saying you might want to

1	give the people in the front row
2	MS. BONAVENTURE: Okay. Absolutely.
3	THE COURT: [indiscernible] of maybe like four feet, four
4	feet.
5	MS. BONAVENTURE: Uh-huh, sure. Yeah. Absolutely.
6	Thank you.
7	THE COURT: Okay.
8	MS. BONAVENTURE: I didn't even notice.
9	THE COURT: That's okay.
10	MS. BONAVENTURE: Obviously.
11	[Bench conference was concluded.]
12	MS. BONAVENTURE: I apologize if I've gotten too close to
13	you guys. The judge pointed out that you guys didn't know where to
14	look. So I do apologize if I've been getting too close.
15	So Jack Yeh hi, Mr. Yeh, how are you?
16	PROSPECTIVE JUROR NO. 279: Fine. Thank you.
17	MS. BONAVENTURE: So I noticed you said that you are
18	from Taiwan, originally.
19	PROSPECTIVE JUROR NO. 279: Yes.
20	MS. BONAVENTURE: Okay. And is English your second
21	language?
22	PROSPECTIVE JUROR NO. 279: Second.
23	MS. BONAVENTURE: Second language. But you feel very
24	comfortable in your ability to understand and speak the English
25	language?

PROSPECTIVE JUROR NO. 279: Yeah. If I don't
 understand, I can listen -- if I don't understand, still listen, you know.
 I -- I --

MS. BONAVENTURE: I'm sorry.

PROSPECTIVE JUROR NO. 279: I don't understand how
things, but I try to listen, you know.

7 MS. BONAVENTURE: Uh-huh okay. And so because when you get back into the jury room, you're -- if you're -- well, if you're left 8 here to be part of our jury, you know, there's going to be a lot of 9 contention. There's going to be a lot of people arguing about what 10 11 they believe to be true and what they don't believe to be true, who they believe and who they don't believe. Do you think that your -- the 12 fact that English is your second language and maybe you don't feel 13 as comfortable as everybody else as expressing your opinion, that 14 you would still be able to hold fast to your beliefs and listen to 15 everybody else and be able to communicate to them what you 16 believe and what you don't believe to be true and to participate? 17 PROSPECTIVE JUROR NO. 279: Before I understand whole 18 thing, I won't say anything yes or no or, you know, because I just, you 19 know, can't say anything before I understand whole thing. 20 MS. BONAVENTURE: Okay. And so you have understood 21 that's been going on today? 22 PROSPECTIVE JUROR NO. 279: Just about half. 23 MS. BONAVENTURE: About half? Okay. Do you think that 24 if we were to proceed with trial, that you would be able to understand 25

1	everything that's going on?
2	PROSPECTIVE JUROR NO. 279: Probably not.
3	MS. BONAVENTURE: Probably not?
4	PROSPECTIVE JUROR NO. 279: Yeah.
5	MS. BONAVENTURE: Okay. Okay. Okay. And okay. So
6	I see that you do work for Mandalay Bay as a cook. I am sorry for
7	what happened at Mandalay Bay. But you don't interact with people
8	on a daily basis, as far as like customers or practice your language
9	skills every day?
10	PROSPECTIVE JUROR NO. 279: That kind of conversations,
11	because we talk I mean, all the time, so we can understand I
12	mean, I can understand, you know, more than like this kind of
13	conversation. This kind of, you know, things I don't really can go in
14	because I don't, you know I don't really touch that much kind of
15	thing.
16	MS. BONAVENTURE: Okay. Okay. All right. Thank you,
17	Mr. Yeh.
18	Ms. Huber, is that how you pronounce your name?
19	PROSPECTIVE JUROR NO. 281: Yes.
20	MS. BONAVENTURE: Hi. So on when the judge was
21	asking questions, I definitely made a note of the fact that you said
22	that you do not believe that you would be able to be fair and
23	impartial.
24	PROSPECTIVE JUROR NO. 281: I don't believe I said that.
25	MS. BONAVENTURE: Okay.

1	PROSPECTIVE JUROR NO. 281: I believe I what the
2	question was is my feelings about the officers, police, and would I
3	consider their them as more truthful or and I said yes, I would.
4	MS. BONAVENTURE: Okay.
5	PROSPECTIVE JUROR NO. 281: But then the question was,
6	could I be impartial based on evidence? And the answer is yes.
7	MS. BONAVENTURE: Okay. So you wouldn't just take
8	somebody's word for whatever is coming out of the mouth, whether
9	they had a uniform on or not?
10	PROSPECTIVE JUROR NO. 281: Correct. I would not.
11	MS. BONAVENTURE: Okay. So you would like something
12	to substantiate what they're saying.
13	PROSPECTIVE JUROR NO. 281: Yes.
14	MS. BONAVENTURE: Whether it be medical documents,
15	another witness, something to that effect?
16	PROSPECTIVE JUROR NO. 281: Yes.
17	MS. BONAVENTURE: Okay. So but you then you do
18	believe that you could be a fair and impartial juror?
19	PROSPECTIVE JUROR NO. 281: Correct.
20	MS. BONAVENTURE: Okay.
21	PROSPECTIVE JUROR NO. 281: I could.
22	MS. BONAVENTURE: Okay. So if Mr. Allen took the stand,
23	you wouldn't just not believe him, correct, based on the fact that he
24	was not in uniform?
25	PROSPECTIVE JUROR NO. 281: Correct. I would listen to

1	the evidence presented.
2	MS. BONAVENTURE: Okay.
3	PROSPECTIVE JUROR NO. 281: And make the decision
4	based on that.
5	MS. BONAVENTURE: Okay. So if an officer took the stand
6	and said one thing that contradicted what Mr. Allen said, obviously
7	you would have to take all the information into account, but just
8	because the officer was wearing a uniform, you wouldn't just take his
9	version of events, would you?
10	PROSPECTIVE JUROR NO. 281: No.
11	MS. BONAVENTURE: Okay.
12	PROSPECTIVE JUROR NO. 281: Of course not.
13	MS. BONAVENTURE: Okay. So you would look at
14	everything holistically and look at the big picture?
15	PROSPECTIVE JUROR NO. 281: Correct.
16	MS. BONAVENTURE: Okay. Okay. Thank you.
17	Ms. Westbay? Okay. I don't know how common the last
18	name Westbay is, but are you related to a Stephanie Westbay?
19	PROSPECTIVE JUROR NO. 289: Yes.
20	MS. BONAVENTURE: Is she currently a clerk in
21	PROSPECTIVE JUROR NO. 289: Well, she's my
22	ex-husband's ex-wife.
23	MS. BONAVENTURE: Okay. So your ex oh, your
24	ex-husband's ex-wife? Okay. And have you ever had any
25	communications with her?

1	PROSPECTIVE JUROR NO. 289: Yes.
2	MS. BONAVENTURE: Okay. Are you guys on good terms
3	or bad terms?
4	PROSPECTIVE JUROR NO. 289: They're not good.
5	MS. BONAVENTURE: They're not good? So you don't
6	communicate with her? Okay.
7	PROSPECTIVE JUROR NO. 289: I try not to.
8	MS. BONAVENTURE: Okay. And do you know what she
9	she does as an occupation?
10	PROSPECTIVE JUROR NO. 289: Yes.
11	MS. BONAVENTURE: Okay. Does that or has that ever
12	affected your view of the criminal justice system?
13	PROSPECTIVE JUROR NO. 289: No, not based on her, no.
14	MS. BONAVENTURE: Okay. Okay. So you wouldn't that
15	wouldn't color anything that you would see here in making your
16	decision?
17	PROSPECTIVE JUROR NO. 289: No.
18	MS. BONAVENTURE: Okay. So now, I see here that you've
19	received a doctorate degree; is that correct?
20	PROSPECTIVE JUROR NO. 289: Huh-uh.
21	MS. BONAVENTURE: Okay. Then that must be wrong,
22	because it says that right here for level of education.
23	You what was your level of education?
24	PROSPECTIVE JUROR NO. 289: GED.
25	MS. BONAVENTURE: A GED? Okay. And I know you said

1	that your boyfriend is this a current boyfriend was a cop or an
2	ex-boyfriend?
3	PROSPECTIVE JUROR NO. 289: He passed away this
4	month.
5	MS. BONAVENTURE: Oh, he I'm so sorry for your loss.
6	He passed away this very month?
7	PROSPECTIVE JUROR NO. 289: Yes.
8	MS. BONAVENTURE: Okay.
9	PROSPECTIVE JUROR NO. 289: The 25th.
10	MS. BONAVENTURE: Okay. All right. Thank you,
11	Ms. Westbay.
12	And I actually don't have any questions for you,
13	Mr. Caldonetti.
14	Ms. Escalona, how are you?
15	PROSPECTIVE JUROR NO. 300: I'm good.
16	MS. BONAVENTURE: Good. I'll try to be brief with you,
17	but I do want to address any language barriers that we may have.
18	Are you originally from the United States?
19	PROSPECTIVE JUROR NO. 300: Yes.
20	MS. BONAVENTURE: Okay. Is English your first language?
21	PROSPECTIVE JUROR NO. 300: Yes.
22	MS. BONAVENTURE: Oh, okay.
23	PROSPECTIVE JUROR NO. 300: No, second.
24	MS. BONAVENTURE: It's your second language?
25	PROSPECTIVE JUROR NO. 300: Yes.

1	MS. BONAVENTURE: Okay. What's your first language?
2	PROSPECTIVE JUROR NO. 300: Tagalog.
3	MS. BONAVENTURE: Tagalog? Okay. And have you been
4	able to understand everything that's been going on today?
5	PROSPECTIVE JUROR NO. 300: Little bit.
6	MS. BONAVENTURE: Oh, only a little bit? How have
7	like, if you could give me a percentage, is there a certain percentage?
8	PROSPECTIVE JUROR NO. 300: Yes.
9	MS. BONAVENTURE: So how much do you think you've
10	been understanding? 50 percent? 60 percent?
11	PROSPECTIVE JUROR NO. 300: 80 percent.
12	MS. BONAVENTURE: 80 percent?
13	PROSPECTIVE JUROR NO. 300: Yes.
14	MS. BONAVENTURE: Okay. That's not so bad. Because
15	I and I asked you because I know you you were really quiet.
16	You're like the only person quieter than the judge, I think. So I
17	that's why your English skills are probably a lot better than I thought,
18	because I don't think I could hear you.
19	Okay. Great. So do you think that you would be able to
20	understand at least the majority of what's going on [indiscernible]?
21	PROSPECTIVE JUROR NO. 300: Yes.
22	MS. BONAVENTURE: Okay. And do you think you'd be
23	able to stand your ground if there was something you believed was
24	true or not true when you go back to argue, because essentially you
25	guys will all be discussing and debating the facts of this case to come

1	to a verdict, be it guilty or not guilty. If you had a certain a
2	conviction, do you think that you would be able to stand by that
3	conviction and not feel overwhelmed by people just because you may
4	not understand 100 percent of what's going on around you?
5	PROSPECTIVE JUROR NO. 300: No, I don't.
6	MS. BONAVENTURE: You don't think you'd be able to
7	stand your ground? You can be absolutely honest. That's why I'm
8	asking the question. You don't think you could stand your ground?
9	You think you might be a little bit intimidated by the people around
10	you?
11	PROSPECTIVE JUROR NO. 300: Yes.
12	MS. BONAVENTURE: Yeah. I mean, you're shrugging like
13	this, so I I believe when you say yes. Okay. All right. Thank you,
14	Ms. Escalona.
15	Mr. Russell.
16	PROSPECTIVE JUROR NO. 309: Good afternoon.
17	MS. BONAVENTURE: So you know I'm going to pick on
18	you.
19	PROSPECTIVE JUROR NO. 309: Sure. Go ahead.
20	MS. BONAVENTURE: Okay. So I know you said that you
21	trust cops, that they're sworn an oath, that they're supposed to be
22	honest. And, of course, they're supposed to be, a majority of them
23	are, but cops aren't infallible; correct?
24	PROSPECTIVE JUROR NO. 309: Probably true.
25	MS. BONAVENTURE: Yeah.

1	PROSPECTIVE JUROR NO. 309: Yeah.
2	MS. BONAVENTURE: And that's that may not even be an
3	issue in this case.
4	PROSPECTIVE JUROR NO. 309: But they're they're
5	human.
6	MS. BONAVENTURE: Right. So they're human and they
7	can they might perceive something differently than somebody else
8	from the fact that they're human; correct?
9	PROSPECTIVE JUROR NO. 309: They're human.
10	MS. BONAVENTURE: So it's always possible for even a
11	police officer to make a mistake?
12	PROSPECTIVE JUROR NO. 309: Yes.
13	MS. BONAVENTURE: Okay. And like I said, that may not
14	even be at issue here in this case, but I just wanted to to hear you
15	say it.
16	PROSPECTIVE JUROR NO. 309: [Indiscernible.]
17	MS. BONAVENTURE: Okay. Let's see. Mr. Varney, I do
18	not have any questions for you.
19	You are Ms. Quidachay?
20	PROSPECTIVE JUROR NO. 340: Quidachay.
21	MS. BONAVENTURE: Quidachay.
22	PROSPECTIVE JUROR NO. 340: Yes.
23	MS. BONAVENTURE: Okay. Ms. Quidachay. So you have
24	five police officers in your family?
25	PROSPECTIVE JUROR NO. 340: Locally, yes.

1	MS. BONAVENTURE: Okay.
2	PROSPECTIVE JUROR NO. 340: Here in Vegas. It's kind of
3	a family thing.
4	MS. BONAVENTURE: Okay.
5	PROSPECTIVE JUROR NO. 340: Police officer, yes.
6	MS. BONAVENTURE: Okay. You know what, I'm pretty
7	sure I don't have anything for you either.
8	PROSPECTIVE JUROR NO. 340: Okay.
9	MS. BONAVENTURE: Okay. Thank you.
10	PROSPECTIVE JUROR NO. 340: Uh-huh.
11	MS. BONAVENTURE: And you're all your husband is a
12	police officer for the Clark County School District?
13	PROSPECTIVE JUROR NO. 340: Yes.
14	MS. BONAVENTURE: Okay. So he deals primarily with
15	what age students?
16	PROSPECTIVE JUROR NO. 340: He's at the high school.
17	MS. BONAVENTURE: Oh, he deal okay. So he deals with
18	high school students. Does he come into contact with any criminal
19	behavior when it comes well, obviously, he's a police officer with
20	the high school students. But is there anything well, he's gone into
21	a loath of this, so I'm not going to beat this horse. So if you want to
22	just pass this the
23	PROSPECTIVE JUROR NO. 340: Thank you.
24	MS. BONAVENTURE: I'm not going to
25	PROSPECTIVE JUROR NO. 340: Thank you.

1	MS. BONAVENTURE: Yeah. You're welcome.
2	So Mr. Hileman
3	PROSPECTIVE JUROR NO. 344: Stone is the last name.
4	MS. BONAVENTURE: Oh, Stone.
5	PROSPECTIVE JUROR NO. 344: Yeah. Hileman is my first
6	name.
7	MS. BONAVENTURE: Okay. What's your first name?
8	PROSPECTIVE JUROR NO. 344: Hileman is my first name.
9	MS. BONAVENTURE: Hileman.
10	PROSPECTIVE JUROR NO. 344: Yeah.
11	MS. BONAVENTURE: Okay. I did pronounce it right.
12	Okay. Mr. Stone, you said that you actually were convicted of these
13	misdemeanor alcohol related offenses?
14	PROSPECTIVE JUROR NO. 344: That's right.
15	MS. BONAVENTURE: And I don't point this out again to
16	to embarrass you, but you did say that you testified at your own trial;
17	correct?
18	PROSPECTIVE JUROR NO. 344: Well, I don't know. I guess
19	I pleaded guilty so to all three offenses.
20	MS. BONAVENTURE: Oh, okay. So they didn't have a trial
21	like this? Or or in the misdemeanor sense, they didn't have a trial?
22	PROSPECTIVE JUROR NO. 344: Yeah. You went to court
23	and you pled and like whatever you are, I just pled guilty, so
24	MS. BONAVENTURE: Okay. So then you didn't testify.
25	You just take or you were charged with something and you took a

1	plea?
2	PROSPECTIVE JUROR NO. 344: I guess.
3	MS. BONAVENTURE: Okay.
4	PROSPECTIVE JUROR NO. 344: [Indiscernible.]
5	MS. BONAVENTURE: So you didn't testify. Having been in
6	that situation, though, you do know that you have a right not to
7	testify against yourself; right?
8	PROSPECTIVE JUROR NO. 344: Yes.
9	MS. BONAVENTURE: Not to give any evidence that would
10	be contrary to any of your best interests, that's the fifth amendment
11	to the constitution; correct?
12	PROSPECTIVE JUROR NO. 344: Yes, it is.
13	MS. BONAVENTURE: Okay. So you realize that as
14	Mr. Allen sits there, he has no absolutely no obligation to get on
15	that stand and say a word?
16	PROSPECTIVE JUROR NO. 344: Yes, I understand that.
17	MS. BONAVENTURE: And can you think of any reasons
18	why he wouldn't do that?
19	PROSPECTIVE JUROR NO. 344: Well, he doesn't have to.
20	MS. BONAVENTURE: Exactly. And maybe I told him don't
21	do it. You know what I mean? Maybe I don't think the State's proved
22	their case, and I've said, Don't get up there; right? Because there's
23	nothing good can come of it; right?
24	PROSPECTIVE JUROR NO. 344: Okay.
25	MS. BONAVENTURE: So there's a lot of reasons why

1	maybe he wouldn't take the stand. Maybe he's really nervous, you
2	know? I know a lot of you sitting here get a little bit nervous, even
3	just being asked questions. So imagine if you were being charged
4	with something and asked extremely sensitive things and anything
5	that came out of your mouth could be taken apart and analyzed and
6	potentially and not potentially, but absolutely used against you.
7	You might elect not to put yourself in that situation.
8	And I don't have questions for you, but I like your costume.
9	Ms. Baynes, you said that you work for a local federal
10	agency, what's that?
11	PROSPECTIVE JUROR NO. 357: National Labor Relations
12	Board.
13	MS. BONAVENTURE: National Labor Relations Board.
14	Okay. And in what capacity do you work for them?
15	PROSPECTIVE JUROR NO. 357: I'm in charge of the office.
16	MS. BONAVENTURE: Of the office?
17	PROSPECTIVE JUROR NO. 357: Yes.
18	MS. BONAVENTURE: Okay.
19	PROSPECTIVE JUROR NO. 357: We investigate and
20	prosecute companies and unions.
21	MS. BONAVENTURE: Oh, you investigate and prosecute
22	PROSPECTIVE JUROR NO. 357: So and prosecute
23	companies and unions who violate labor law.
24	MS. BONAVENTURE: Oh, okay. Gotcha there. And you
25	said your spouse is a fine inspector?

1	PROSPECTIVE JUROR NO. 357: Fire inspector.
2	MS. BONAVENTURE: A fire inspector?
3	PROSPECTIVE JUROR NO. 357: Yeah.
4	MS. BONAVENTURE: Oh, great. Okay.
5	PROSPECTIVE JUROR NO. 357: I probably need the mic to
6	speak up.
7	MS. BONAVENTURE: And you have participated in a civil
8	juror as a civil juror?
9	PROSPECTIVE JUROR NO. 357: Yes.
10	MS. BONAVENTURE: Okay. And you've and do you
11	you realize that the burden of proof is different at different in civil
12	versus criminal cases; correct?
13	PROSPECTIVE JUROR NO. 357: Yes.
14	MS. BONAVENTURE: Do you remember what the burden
15	of proof is?
16	PROSPECTIVE JUROR NO. 357: No. But if you tell me, I
17	can pretty much apply.
18	MS. BONAVENTURE: Well, here it's beyond a reasonable
19	doubt. I think over there it's
20	MALE SPEAKER: Preponderance of the evidence.
21	MS. BONAVENTURE: There you go, preponderance of the
22	evidence. Okay. So there is a very big difference between a civil and
23	a criminal trial. Here it's beyond a reasonable doubt. The State has
24	to put forth their case to a point where you can sit there and say that
25	he's guilty beyond a reasonable doubt, without any doubt in your

1	mind that he could potentially be innocent. Okay?
2	Ms. Cervantes?
3	PROSPECTIVE JUROR NO. 359: Gates.
4	MS. BONAVENTURE: Ms. Gates, Robyn Gates. Okay. I
5	don't think I have any questions for you either. And I believe I
6	touched on the major things that I wanted to touch upon when I was
7	talking to individual jurors.
8	Is there anybody that feels that there's something stirring
9	deep inside that they really want to say that I didn't ask about and
10	that Mr. Lexis didn't ask about?
11	l see no hands.
12	Yes, sir.
13	PROSPECTIVE JUROR NO. 242: Can we define protected
14	person now or is that going to come out later?
15	MS. BONAVENTURE: The well, for the record, can you
16	state your name and your badge number?
17	PROSPECTIVE JUROR NO. 242: Stephen Fox, 242.
18	MS. BONAVENTURE: Okay. And that will absolutely be
19	addressed during the trial.
20	PROSPECTIVE JUROR NO. 242: Okay.
21	MS. BONAVENTURE: So everything that pertains to the
22	law will should be addressed, and if not, you do have the ability to
23	ask questions and the judge will go through that with you at the
24	beginning of the trial and even right before deliberations.
25	So thank you, guys, so much for all your honesty.

1	THE COURT: Counsel approach.
2	[Bench conference was had and transcribed as follows:]
3	THE COURT: Do you have any stay there. Do you have
4	any challenges for cause?
5	MS. BONAVENTURE: Yes.
6	MR. LEXIS: Yes.
7	MR. HAUSER: Judge, why don't you [indiscernible] just go
8	through all our challenges for cause and get those hammered out, so
9	we're ready to go tomorrow.
10	THE COURT: Okay.
11	MR. HAUSER: And [indiscernible].
12	THE COURT: That's fine. Let's I want to make a
13	complete record, so
14	MR. HAUSER: Yeah.
15	THE COURT: I agree.
16	[Bench conference was concluded.]
17	THE COURT: Ladies and gentlemen, we're going to take
18	our evening recess. You all are going to be required to come back
19	tomorrow afternoon. We're going to reconvene at 1 o'clock in this
20	courtroom.
21	So where do they need to come back? They're all going to
22	have to come back tomorrow. Where do you want them to out in
23	the hallway or where do you want them?
24	And I don't know who or will be on the jury. I do want you
25	to know there was one person I believe had concerns. She prepared

1	payroll. The schedule is going to be we're going to on
2	Wednesday we're going to start at 1 o'clock. So you would have your
3	mornings to do whatever you need to do. And then Thursday we're
4	probably going to start either late morning or more probably

11	THE COURT: All right. Here's the situation, Counsel. It's 5

20	can't be fair. It doesn't mean he can't be impartial. It's not enough
21	for cause in this case.
22	THE COURT: Okay. State, any response?
23	MR. LEXIS: I flat out asked him if that was the law, that the
24	State would just put one witness on the stand, do you believe beyond
25	a reasonable doubt can you find guilty? He unequivocally said no.

THE COURT: Okay. But that was in the hypothetical 1 2 situation. I'm going to instruct him on the law and he's going to hear 3 the facts. He had informed the Court that he could be fair and impartial and that he would follow my instructions. I'm not going to 4 dismiss him for cause. I'm not going to -- I'm sorry, I'm not going to 5 excuse him for cause. 6 7 So we're going to need to seat three new jurors tomorrow, 8 go through the questions. MR. LEXIS: And, Your Honor, I -- I asked him, if that was 9 the law, would you be able -- the State asked you to follow up with 10 11 them and say -- flat out say, if I instruct you that the State just needs one witness and if you prove -- they prove beyond a reasonable 12 doubt defendant's guilty, can you find guilty? And --13 THE COURT: Okay. But that was a hypothetical, Counsel. 14 That isn't -- I'm going to instruct him on what the law is. I'm going to 15 give him jury instructions. 16 You were giving him a hypothetical, and without him 17 hearing and he was equivocal. I did not hear him say that he was not 18 going to be fair and impartial or that he would not follow the law. 19 You were giving hypotheticals as to what the law was and what the 20 facts may be. I'm not going to dismiss him for cause -- I mean, 21 excuse me -- I'm not going to excuse him for cause. 22 Anything else? 23 MR. LEXIS: No, Your Honor. 24 MR. HAUSER: No, Your Honor. We'll see you tomorrow. 25

1	MR. LEXIS: Just so the
2	THE COURT: I'm sorry, Counsel.
3	MR. LEXIS: Just so the Court knows, we put some exhibits
4	to be marked. They're the photos.
5	THE COURT: Let me just verify one thing, make sure I'm
6	thinking of the right badge number. Give me your notes on 250.
7	[Pause in proceedings.]
8	THE COURT: I'm going to ask him some follow-up
9	questions tomorrow. It appears you were giving him hypotheticals
10	that I think confused him, quite frankly, Counsel. I'm going to do
11	some follow-up questions tomorrow. But as of right now, I'm not
12	going to excuse him for cause.
13	I'll do some follow-up questions. I'll give you an
14	opportunity to do some follow-up questions. But at this point, I'm not
15	going to excuse him for cause.
16	MR. LEXIS: And, Judge, for the record, and also defense
17	counsel too, because I just found more there's pictures, there's
18	medical records, and then there's also a body cam clip. And I edited
19	the clip, obviously to stop any a lot of prior bad act stuff that's said
20	on the body cam in the continuing investigation of what was going
21	on. So I cut out the audio, and I only have it up to basically a little bit
22	after the officer gets there him getting there, and then a little bit
23	until after.
24	THE COURT: Okay. And this
25	MR. LEXIS: I did

1	THE COURT: Go ahead. I'm sorry, Counsel.
2	MR. LEXIS: I did that for the benefit of the defendant and
3	to keep stuff out like that. The only thing I would ask is that the Court
4	instruct the jury that when we do play it, that it is was edited at the
5	Court's request, so they don't think any side is hiding anything.
6	If they want to bring in the entire body cam, that's fine with
7	me. But again, I it's edited for the protection of the defendant. And
8	so that's all I would just ask the Court to say it was edited at the
9	Court's request.
10	THE COURT: Okay. Provide me with the limiting
11	instruction you want me to give.
12	And has this been provided to defense counsel through
13	discovery?
14	MR. LEXIS: Yes, Your Honor.
15	MS. BONAVENTURE: The entire video was provided to us,
16	not the uncut or not the cut version of it.
17	MR. LEXIS: And I will provide them a copy of that as
18	THE COURT: Okay. You need to review it. Tell me if you
19	have any objections.
20	MS. BONAVENTURE: Okay.
21	THE COURT: Obviously, you are entitled to have the full
22	video played if that's what you want.
23	MS. BONAVENTURE: Okay.
24	THE COURT: I mean, you didn't file any type of motion to
25	suppress the video, anything of that nature; correct?

1	MS. BONAVENTURE: No. There was no motion to
2	suppress the body cam video.

did get the jury instructions. I appreciate that. And I've reviewed
them and pulled the case laws that supports them.

So again, you have the rest of this evening to meet and
confer regarding any stipulations, regarding evidence or exhibits,
including the videotape. We'll reconvene tomorrow at 12:45, and the
jury will be here at 1:00. I'd like to get the jury selected by tomorrow.
Okay.

MR. LEXIS: And, Your Honor, just so you know, I'm not
asking for any jury instruction on this. But what we normally do in
the other courtrooms is just before we play it, the Court just informs
the jury before we play it it's been edited at the Court's request for
time purposes or however you want to do it.

THE COURT: I understand.
