B. Nature of Emergency

The concurrently filed petition for writ of prohibition calls for this Court's emergency intervention. Without immediate relief, the tran-

script from today's hearing, once prepared, will be publicly filed and will irreversibly disclose Ms. Wynn's confidential information. The hearing had been sealed because Wynn Resorts, over Ms. Wynn's objection, discussed Ms. Wynn's confidential information. The district court granted a temporary stay of the underlying confidentiality issues but announced that the transcript from the hearing would be immediately and publicly filed, defeating the purpose of the stay.
