

Pursuant to Nevada Rule of Appellate Procedure 29, University of Nevada, Las Vegas, William S. Boyd School of Law Professor Bret Birdsong and the professors listed in the appendix to this motion (collectively, "Proposed Amici") respectfully request leave to file the accompanying brief in support of Appellants' Opening Brief.

The questions at issue in this proceeding have been accepted by this Court on certification from the United States Court of Appeals for the Ninth Circuit. That court previously granted several of the present Proposed Amici leave to file an amicus brief in this case in support of Appellants Mineral County and Walker Lake Working Group. In their brief before the Ninth Circuit, amici law professors argued that the federal district court erred in treating the public trust doctrine as new in Nevada law and in misconceiving the relationship between takings and water law. Alternatively, amici suggested that the Ninth Circuit certify the relevant issues to the Nevada Supreme Court. The Ninth Circuit has now certified two questions to this Court regarding: (1) whether the Nevada public trust doctrine applies to adjudicated appropriative water rights and, if so, to what extent; and (2) whether the application of the public trust doctrine to adjudicated water rights to allocate water to Walker Lake constitutes a taking. Proposed Amici believe that their brief will be helpful to the Court in answering these certified questions

Proposed Amici are professors and scholars who teach, research, and write on water and property law. Proposed Amici teach courses that cover the public trust doctrine, prior appropriation of water, and the constitutional issue of takings of property. As a group, Proposed Amici have decades of experience studying and teaching water and property law and have published numerous books and articles about those areas, including leading casebooks. Many also have written articles,

books, and other scholarly works specifically about the public trust doctrine, western water law and the federal takings clause. On the basis of their expertise and collective experience, Proposed Amici can inform the Court about the relationships among takings doctrine, the public trust doctrine, and prior appropriation of water. Those relationships are, of course, the central focus of the certified questions before the Court in this case.

Proposed Amici are joined and represented by their undersigned counsel, Bret Birdsong, Professor of Law at the William S. Boyd School of Law at the University of Nevada, Las Vegas. Professor Birdsong teaches, among other subjects, water law, including Nevada water law, and has written and/or edited articles and book chapters involving water and other natural resources. He has been assisted in the preparation of this brief by students as part of the law school's Thomas and Mack Legal Clinic. Professor Birdsong is a member in good standing of the Nevada State Bar.

For the foregoing reasons, Proposed Amici respectfully request that the Court grant leave to file the brief amicus curie being filed with the Court simultaneously with this motion.
